Selectmen Present: Chairman Shawn O'Neil, Kimberly Farah, Judi Cogswell, Sheila Johannesen Absent: Vice-Chair Chris Giordano

Chairman O'Neil opened the meeting with a moment of silence for the troops who put themselves in harms way. All stood for the Pledge of Allegiance.

I. Delegate Session

An audit of the Police Officer rate structure for special detail rates was performed and it was recommended to the Board by Chief Parsons to increase this by \$4.00 for each line item.

Selectman Farah made the motion, seconded by Selectman Johannesen, to approve the new proposed rate structure for special detail rates; **motion passed.**

The research that was conducted on the Meetinghouse has been completed. It was reviewed in a non-public session.

Selectman Farah made the motion, seconded by Selectman Cogswell, to unseal the research report on the Meetinghouse; **motion passed unanimously.**

II. Minutes

Selectman Farah made the motion, seconded by Selectman Johannesen, to approve the November 7, 2016 public minutes as amended; **motion passed.**

November 7, 2016 non-public minutes will be amended in non-public session.

III. School Board Rep- Rob Collins and School Budget Rep- John Hughes

There was discussion about full time kindergarten being in the district which is not mandated by the State. When full time kindergarten was implemented all were under the impression it would be at no cost to the tax payers. Selectman Farah asked if there was a cost for full time kindergarten to the tax payers. Mr. Collins said that there was no cost but it is expected to have revenue. This will be researched for a more definitive answer. A lengthy discussion of half-time versus full-time kindergarten followed.

There have been issues with the tax rate being set late because the school MS-20 form was late to be submitted. The MS-20 form will not be accepted by all 4 towns until all the filings have been in place, such as impact fees. Mr. Collins explained the sequence of events that caused the MS-20 form to be released from DRA later than expected.

Selectman Farah asked about the proposed budget and what was expected. Mr. Hughes explained some increases and decreases within the budget and noted they are still working on the budget. Mr. Collins explained how capital improvements are prioritized through open discussions and not a plan.

Enrollment is currently down but it is projected to increase in a short amount of time. The breakdown of the budget in regards to each town was explained.

The number of administrators is expected to remain the same even when the enrollment is decreasing. There are Principles placed at every school, which Rob stated is mandated by the State. There were teacher cuts last year, but not administrators. The BOS questioned this.

Selectman Farah asked about the financial impact there was from implementing a Spanish program at the elementary schools. Mr. Collins did not know. The kindergarten committee will look into the Spanish program.

There was a lengthy discussion about class room size, teachers, and budget cuts.

Chairman O'Neil read a letter from School Board Rep Stephanie Dube regarding her absence. (attached)

IV. Budgets

a. Cemetery

Overall the budget has decreased. The Additional work line item was reduced to \$10 just to keep the line item open for future purposes.

Selectman Johannesen made the motion, seconded by Selectman Farah, to approve the proposed 2017 budget for 4195.10 Town Cemeteries in the amount of \$23,1600; **motion passed.**

b. Household Hazardous Waste

Selectman Johannesen made the motion, seconded by Selectman Farah to approve the proposed 2017 budget for 4323.20 Hazardous Waste Collection in the amount of \$6,000; **motion passed.**

c. Main Recreational Facilities

Selectman Johannesen made the motion, seconded by Selectman Farah, to approve the proposed 2017 budget for 4520.60 Maintenance of Recreational Facilities in the amount of \$9,000; **motion passed.**

d. Highway-Road Maintenance

Mr. Caillouette presented the Highway budget. There was a budget increase for Major Road Repairs. Fuel for small equipment increased by \$25. Fuel for highway truck decreased by over \$1,000.

Selectman Farah made the motion, seconded by Selectman Johannesen, to approve the proposed 2017 budget for 4321.20 Road Maintenance in the amount of \$446,047; **motion passed.**

e. Winter

Increase in Machinery and equipment by \$3,000 because he is looking to purchase a new plow and a wing.

Selectman Farah made the motion, seconded by Selectman Johannesen, to approve the proposed 2017 budget for 4312.50 Winter in the amount of \$170,000; **motion passed.**

f. Storm Water Management

Lengthy discussion about Storm water consultant and report.

Selectman Farah made the motion, seconded by Selectman Johannesen, to approve the 2017 proposed budget for 4312.30 Storm Water Management in the amount of \$12,500; **motion passed.**

V. Old/New Business

Chairman O'Neil is still in contact with Casella and negotiating the new contract.

The warrant article for the Elderly Exemption increase was worked on by Selectman Farah and Patty. The Warrant Article was amended to reflect the increase in the cost of living.

Selectman Farah made the motion, seconded by Selectman Farah, to update the warrant article with the updated information presented; **motion passed.**

Article 2017-00 (approved 11/7/16); (modified 11/14/16) Modify the Elderly Exemption

"Shall we modify the elderly exemption from property tax in the Town of Danville, based on assessed value, for qualified taxpayers, to be the following: for a person 65 years of age up to 74 years, Seventy-three thousand Eight Hundred Sixty-Four Dollars and Fifty-Three cents (\$73,864.53); for a person 75 years of age up to 79 years, One-Hundred Five Thousand Seven Hundred Sixty Dollars and Eight cents (\$105,760.08); for a person 80 years of age or older, One Hundred Thirty Thousand One Hundred One Dollars and Ninety-Nine cents (\$130,101.99). To qualify, the person much have been a New Hampshire resident for at least three consecutive years, the person may own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married for at least 5 years and the property must be the primary residence. In addition, the taxpayer must have a net income of not more than Thirty-Five Thousand Two-Hundred Dollars (\$35,200) or, if married, a combined net income of less than Forty-Four Thousand Dollars (\$44,000); and own net assets not in excess of Seventy-Seven Thousands Dollars (\$77,000) excluding the value of the person's residence." This article shall take effect for the 2017 property tax year. (Majority vote required).

Chairman O'Neil asked Patty to include the current figures into the written discussion of this article.

Selectman Farah made the motion, seconded by Selectman Johannesen, to move the new Police Station capital reserve fund warrant article forward; **motion passed.**

Selectman Farah made the motion, seconded by Selectman Johannesen, to put recommended by the Board of Selectman; **motion passed.** 4-0

New Police Station Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Twenty Thousand Dollars (\$20,000) to be added to the New Police Station Capital Reserve Fund previously established.
