Selectmen opened the bids received for the Cheney Road Project. One bid for \$7,600.00 was submitted by AcreShaper. Chairman O'Neil stated the board would pass the bid to the Road Agent to review and submit his recommendation. Selectmen signed payroll, vendor, and Library Payroll Warrants 2017-19, a tax payment plan, and a Timber Cut.

Borucki made the motion, seconded by Johannesen, to approve the **4316.1 Street Lighting budget for \$7,550**; motion passed.

Johannesen made the motion, seconded by Borucki, to approve the **4150.5 Treasurer budget for \$10,673**; motion passed.

Johannesen made the motion, seconded by Borucki, to approve the **4440 Welfare budget for \$66,178 to include: 4441.1 General Assistance for \$7,346, 4442.1 Direct Assistance for \$27,700, 4445.2 Vendor Payments for \$31,132**; motion passed.

III. Old / New Business

The Board discussed the Town's current holiday schedule compared with the State's holiday schedule. It was decided to postpone any changes until when the full board could convene.
