Selectmen Present: Shawn O'Neil, Chair; Dennis Griffiths, Vice Chair, Sheila Johannesen, Joe Hester, Annemarie Inman

Others Present: Gail Turelli, Land Use Administrator; Residents: Doug Anderson of Doug's Tree Service; Logan Silver; Steven and Bianca Marschner

Shawn called the meeting to order at 6:55 PM and opened the meeting with a moment of silence for the troops who put themselves in harm's way. All stood for the Pledge of Allegiance

**I. Delegate Session**

Shawn opens the Delegate Session and asks if there are any members of the public not on the agenda who wish to address the BOS. As no members of the public wished to speak, Shawn closes the Delegate session at 6:57 PM

**II. Agenda**

**Doug Anderson (Doug's Tree Service):** Shawn explains to the BOS that the Planning Board had placed conditions on Doug Anderson and his business to resolve some issues. The conditions were not met, so the BOS issued a cease-and-desist order on Doug's Tree Service until the corrections were made. He confirms that Mr. Anderson has since met with the Planning Board and the situation has been remedied.

Shawn asks Mr. Anderson why he didn't follow the conditions the Planning Board had originally put in place. Mr. Anderson explains that he was unaware there was a one-year timeline to complete everything and believed any issues would be addressed when he went before the Planning Board for the second portion of the project. He states that he was confused because he found out about the timeline after the fact and he thought someone would have called him and let him know he was almost out of his year and he would need to write for an extension. Mr. Anderson notes that the matter is neither here nor there, several thousands of dollars later.

Shawn explains the BOS must do their side too and tries to work with everyone. He states the onus is on Mr. Anderson to understand the conditions. Mr. Anderson reiterates it's over with. Shawn confirms with Gail the Planning Board had approved Mr. Anderson's project and the BOS can now relinquish the cease-and-desist order. Shawn motions for the BOS to release the cease-and-desist order on Doug Anderson/Anderson's Tree Service. Second by Sheila. There is further discussion.

Dennis states he reviewed the Planning Board minutes and feels there are inaccuracies between the minutes and the video, noting the minutes have not been approved yet. He explains he is uncomfortable with not understanding exactly what went on. He did watch the video and knows that Mr. Hantman added seven special needs. Dennis states his biggest hesitation is that Mr. Anderson needs to take responsibility for the issues going forward. Mr. Anderson responds that he admitted it was an oversight on his part. He is taking steps and has a grader lined up, and is meeting with Mr. Seaver (Road Agent) to have him explain where Mr. Anderson needs to put the silt socks. Dennis confirms the Planning Board decided on using silt socks. Mr. Anderson states they agreed that he needs to install them on the entryway coming in, on both sides of the road where the paved driveway is coming in plus five (5) feet beyond that point. Mr. Seaver will inspect the area before, during, and after the work to make sure the installation adheres to

the Town's criteria from pavement to pavement. Dennis clarifies Mr. Anderson is just storing firewood and confirmed that Mr. Anderson understands he is in the Commercial/Industrial zone with separate zoning rules, including that Mr. Anderson cannot build a home there. Mr. Anderson states that he can build a building there. Dennis reiterates that Mr. Anderson cannot build a residence there. Mr. Anderson disagrees stating if Dennis checks the by-laws he can (build a home). Dennis adamantly states that he can't. Mr. Anderson states he is not at the BOS meeting for this (issue) and he will bring a lawyer for that. He states the by-laws state he can have residency in the building if it creates a hardship and suggests that Dennis check the zoning. Mr. Anderson continues that he has already read the zoning laws, his lawyer has read them, Mr. Hantman has already agreed to it, and reiterates this is not the reason he is at tonight's BOS meeting.

Dennis states that as a Selectman, his job is to understand every angle and he doesn't have every angle because he was not involved in it until recently, so he is just asking questions. Mr. Anderson states he has been at this for three (3) years and is ready to sell the property because he didn't think it would be this hard to run a firewood business from a piece of land that is agricultural. Dennis explains that every town has rules and Danville has zoning rules. Mr. Anderson states that he is not at tonight's meeting to argue and that can be done at another meeting. He just wants the BOS's blessings to release the cease-and-desist so he doesn't have to bring his attorney to the meeting. Sheila and Shawn agree the BOS is addressing the cease-and-desist order.

Joe states he was at the Planning Board meeting as the BOS representative and believes the Planning Board wanted to at least get the pavement done. Mr. Anderson states he has a year to ensure that is done and he will have it done before summer. Joe reiterates he's bringing this information back to the BOS from the Planning Board that until the pavement is done, the cease-and-desist should stay in place. Mr. Anderson states that's not right. Joe reiterates it was the feeling of the Planning Board. Mr. Anderson confirms that Gail was at that meeting and the Planning Board gave him the removal of the cease-and-desist order as part of the conditions. Shawn explains the Planning Board cannot remove a cease-and-desist order.

Mr. Anderson reiterates the Planning Board recommended the cease-and-desist order be removed under the conditions the pavement would be done as part of the pre-approval. Sheila states she watched the meeting and the cease-and-desist was discussed a little. Dennis asks if it was discussed after all the waivers went through. Mr. Anderson states the Planning Board granted removal, but it had to come from the BOS but saw no reason that it couldn't be removed.

Shawn confirms that Mr. Anderson will meet the conditions (from the Planning Board) before summer, noting that is only a couple of months away. He asks if Mr. Anderson will go on record that he will have this done in sixty (60) days. Mr. Anderson refuses to go on record. He states that is not summer, and they will be done before fall. He also states that he will not be pulling anything out of there. The wood sitting there will be there until the fall. Mr. Anderson notes there will hardly be any traffic going in and out of there right now. The Planning Board told him he had one year to get that done and Chip (Current) told him not to make the mistake and plan on the Planning Board's good graces if he didn't have this done the next time. Mr. Anderson reiterates his misunderstanding that it needed to be done within a year and he wants to put his building there. If he can't get his building done, and can't get his road in there, there is no sense in him staying in Town, so he wants it done. He has to wait until he has a paver coming and get the Road Agent there so he can explain to the pavers what needs to be done so everything meets the final criteria. Mr. Anderson states the Planning Board gave him the conditions last year of what needed to be done but didn't give him a cease-and-desist so that he couldn't work there. Sheila explains the cease-and-desist came from the BOS. Mr. Anderson states he had things he had to get done in that year and did some, but didn't do the road because he didn't think it had to be done in that year.

Annemarie states this is a matter of process. The cease-and-desist order has to be released in order for Mr. Anderson to do anything, so it's a catch-all. She states Mr. Anderson has been put on notice that he has a year to do these things, and is now aware of the timeframe. Annemarie states she feels the BOS is at the spot. Shawn reminds Mr. Anderson that he should not rely on the BOS' good graces to release the cease-and-desist order the next time. Mr. Anderson states he will take ownership of that. Shawn states he wants to be clear. He understands Mr. Anderson

wants to run his business and the BOS wants to be helpful but has to protect what the Townspeople have administered in their vote and regulations.

Shawn calls the question on his motion to release the cease-and-desist order on Doug Anderson/Anderson's Tree Service. Vote is 4-yes, 1-no, 0- abstentions (4-1-0). Dennis votes no. The cease-and-desist will be released. Shawn explains that Mr. Anderson can pick up the paperwork tomorrow. Mr. Anderson asks that the paperwork also be forwarded to Henry, Justin, and himself.

**ATV Permission Permits:** Shawn addresses Steven and Bianca Marschner. They explain they are at the meeting to show their faces about the four-wheeling. Ms. Marschner states that she spoke to Kim and was told to come to the meeting and introduce themselves. Shawn confirms they are the two (2) people that Dave Drislane did not know. Mr. Marschner states he and Mr. Drislane just met on the trail and Mr. Drislane had recommended that he be nominated for permission (to ride). Shawn states that if Mr. Drislane does not know somebody, he wants to make it very clear so he goes over the rules. Shawn explains that by applying for (ATV) riding permission, the BOS wants to make it very clear the only place in Town the BOS is giving permission to ride on is the right-of-way on Town-owned property the trail goes through. Riders have to get written permission from each landowner whose property they ride through and the Fish and Game laws are very clear on that. The permission is only for access to the Town-owned segments of the 300' right-of-way under the powerlines. The (ATV) group has received permission from the other landowners to allow riders to ride on their lands which gives access (to the powerlines). Shawn explains the Town Warrant just passed to continue the ATV permission program<sup>i</sup> and if Mr. Drislane doesn't know someone, he tells them to come to a BOS meeting to demonstrate their commitment. Shawn states he wants the applicant to have a conversation with the BOS so they are aware of the rules and everyone is on the same page. Mr. and Ms. Marschner agree. Shawn states he has no problem signing their permission applications. Mr. Marschner confirms that he can return to pick up his permission form. Shawn assures him it will be signed at tonight's meeting.

Mr. Marschner states he has a question regarding the Town line (on the map) and asks if he needs to speak to Mr. Drislane or if the BOS can answer his question. Shawn states that he knows a little bit about the map. He confirms the red lines are the authorized trails and riders need to stay on the dashed lines, even though the other property is also Town property. Mr. Marschner asks about the spaces between two red lines. Dennis explains that is privately owned land and the landowner owns the land on both sides of the powerlines. He has posted permission for riders to cut through there. Mr. Marschner asks about a smaller cut. Dennis suggests that he confirm the map with Mr. Drislane, but he believes that is another private landowner with whom Mr. Drislane is trying to get permission (to ride). Mr. Marschner notes that he lives at 33 Sandown. Dennis explains that as long as he stays under the power lines, no one should bother him. He notes that is where Fish and Game was grabbing everyone until the BOS put the permission process in place. Dennis encourages Mr. Marschner to talk to Kim if he has any further questions.

Logan Silver explains that he is at the BOS meeting for the same reason and believes the BOS has signed his application. Shawn reiterates that Mr. Drislane is the first line of information and if he doesn't know the applicants, the BOS is concerned about people riding off the trail, noting that Fish and Game will hand out nice big tickets and this is what the permissions hope to prevent. By having the applicant come to a BOS meeting, showing 99% of their effort, the riders know ahead of time (where they are allowed to ride). Shawn states he believes Mr. Silver is well aware of the program and has no problem signing his permissions application. Sheila confirms Mr. Silver has a copy of the map. Shawn explains he wants to ensure Mr. Silver understands that just because (the map) shows all the Town property, the permission to ride is only for the right-of-way under the powerlines, approximately 300' wide. Shawn reiterates the other trails in the Town Forest that are not permitted for ATV riding. Mr. Silver clarifies that he can return tomorrow to pick up his permission permit. Shawn explains that everything will be signed and ready for him.

Sheila suggests the BOS put a month/date of expiration on the permission permits because they are only for one year. Shawn agrees the idea has merit to it because the permissions would sunset if people moved out of Town. Shawn suggests marking all the new applications/permits with an expiration date of April 30, 2024, and riders will need to re-apply. Shawn expresses his concern that this should be simple for people, perhaps through an e-mailed renewal. He notes the BOS doesn't need to come up with a process right now, but he does agree the permissions

should sunset for people who move out of Town.

**Security Camera Project:** Dennis states he spoke with Glen Smith and the cameras are high quality but do not have the ability to zoom. He explains that zooming could only happen in real-time. The cameras will provide a good image that can be pinched and zoomed if they are reviewed. Dennis notes that a camera that can zoom is 2.5 times more expensive than a regular camera. The cameras are approximately \$100 each, and cameras with an auto-focus are approximately \$210-\$250 each. Dennis states he is comfortable with the cameras in the quote, but is uncomfortable with the HIK Vision company that makes the cameras and the technology because this is a Chinese company that is partly owned by the Chinese Communist Government. He notes they are not allowed to sell their technology to the US Government. Dennis confirms this company is under government sanctions, but it does not apply to local governments. The cameras can be purchased at the local, retail, and possibly state level, but not by the Federal Government. Annemarie states she has a big problem with that regarding compliance. Shawn suggests the BOS should see if there is alternative equipment. Annemarie states she can screen the company and let the BOS know what they can and can't do with them, but she would not recommend anything sanction-related.

Shawn suggests the BOS is okay with the vendor, but needs alternate cameras. Dennis states he's not completely against HIK Vision but believes everyone should be aware of the issue and it may be the only way to get a quality product. Shawn notes the possibility that every image could be going over to Mainland China. Dennis explains the cameras are a closed-looped system but can talk to each other across the Internet and that is where the closed-loop breaks. The BOS can access the cameras from anywhere via a web browser with pre-determined permissions, but so can anyone else. He suggests moving forward with asking for an alternative product. Shawn asks Gail to put this item back on the agenda for the next BOS meeting.

**Purple Heart Community Update:** Kim has ordered the signs through the NHDOT program. The signs will be installed at the front and back end of Town and the third sign will be installed around the Veteran's Memorial or at Day Field. She has contacted the American Legion for their input. Sheila states she has spoken with the Legion and they are agreeable to having the sign on the Veteran's Memorial. She notes she believes that Kingston and/or Brentwood are also Purple Heart towns.

**Town Website Updating:** Dennis states he is looking for BOS approval to go back to Civic+ and asking them for an upgraded package. He would like to refresh the entire website with a different look. Dennis explains that Civic+ is the Town's website provider, and also provides similar technologies as well as add-ons and plug-ins for many other towns across the country. Dennis notes that Danville's package was installed in 2015 and hasn't been updated since then. Civic+ has since developed new management controls around developing and managing the Town's website and he would like to inquire what would be a good model to update the website and what would it cost for Civic+ to update what the Town currently has. Shawn suggests it is the consensus of the BOS to move forward with getting this information. He states he would like something where department heads could be more self-serving, making it easier for them to do their updates, noting that many are still hesitant to do this. Dennis agrees the current website is clunky.

Sheila explains that when the Town changed to Civic+ in 2015, a lot of Town information was lost. There is a short discussion of the changeover process. Dennis reiterates the current website is tired and an update would allow other people to do their stuff. He notes that he's worked with it, and even as an IT tech, it is clunky. He states he will pursue the issue with the end goal of an updated system that is easier for individuals to manage their stuff and a new look. Shawn reminds Dennis that Civic+ is a template so he won't get a drastic new look. Dennis explains he's trying to encourage people to get more information from the Town's website and that's why he wants a relaunch with a different look, a different color scheme, etc. Joe notes it is important to remember that most people won't search more than three (3) levels down.

**Civic Engage:** Dennis asks the BOS for permission to start visiting the Town's department heads and those responsible for posting information on the website to show them how to update their web pages. Shawn notes this worked well with the recent snowstorm when Casella suspended trash pick-up. He states updates can be used for things like public safety, road closures, etc. Dennis explains the website can also be used as an internal

communication tool. Departments can set up internal groups and send out push notifications to those groups. He reiterates the idea is to facilitate faster and more unified communication.

Annemarie asks if updates to the website would allow residents to ask if they can be put on the BOS agenda. Dennis explains it is not a two-way communication process. Sheila notes that when discussing BOS meetings, board members need to be careful of what they discuss on the website, noting the rules of a quorum. Shawn clarifies the website is a one-way broadcasting network. Annemarie states it would be good for Chris Tracy (Town Clerk) when she is doing her Saturday hours. Shawn notes it would have been good to be able to do this when they had to cancel the BOS meeting at the last minute.

Shawn states he wants to extend kudos to the Fire Dept. for how they dealt with the electrical fire started by the recent thunderstorm.

### **III. Old/New Business**

**Minutes:** The BOS review the minutes for the March 20, 2023 BOS public meeting. Dennis asks to clarify line #195 by changing the term vegetation control to damage control. He also notes that on line #223 there is a typo in the spelling of Mr. Springer's name that needs to be corrected. Dennis motions to approve the minutes as amended. Second by Sheila. Vote is unanimous (5-0).

**Non-Public Minutes:** The review of the minutes for the March 20, 2023, BOS Non-Public session is postponed due to Kim's absence.

**Signature File:** The BOS review and sign the documents in the Signature File.

**Hazardous Mitigation Plan Grant:** Shawn explains the grant has been extended for the updated plan that was worked on during the fall of 2022. Steve had previously worked on it and signed it. Dennis and Sheila need to sign the extension.

Shawn notes there are several applications for various committee appointments in the Signature File. He states he would like to wait until the end of April so that all the departments, boards, and committees have time to make their recommendations. Dennis explains the process of applications and BOS approvals to Joe.

Shawn signs the approval for the re-appointment/re-election of members of the Fire Dept, the Fire Wards, and the Fire Warden

**MS32:** Shawn explains this is the form submitted to the State for the approved Operating Budget. He reminds the BOS that for FY23 the approved budget is the Default Budget.

**Home Occupation Application/Permit:** The BOS review a new application for a home painting business. Sheila asks if this was the same application the BOS had questioned at the last meeting. Gail explains this was a different one, but the one Sheila was referencing is also in tonight's Signature File and that application is in compliance. Sheila asks if a resident can have a hairdresser business in a residential zone. Shawn confirms that a hairdressing business is now an approved home occupation and the application form needed to be updated to reflect that change. He explains that he suspected the business was allowed, but the paperwork that was originally submitted did not match. The exemption now allows one (1) customer at a time. The previous exemption did not allow that to happen. Shawn confirms all the corrections have been made to the paperwork.

**Intent to cut:** Shawn explains the process of permitting and cutting timber on private property and how taxes are assessed for that. Dennis asks if permits were required if a landowner was cutting less than ten (10) trees. There is a short discussion and the consensus is that no permit is needed if the timber being cut totals less than 10,000 board feet.

Town Announcements: Shawn reads the Town Announcements listed below. Sheila adds the following:

- ✚ **Saturday, April 22: Earth Day-** Bag Collection at the Community Center at the front desk 8:00 AM- 10:00 AM. This is for the blue bags.
- ✚ **Saturday, April 29- Household Hazardous Waste Collection Day** in Plaistow, at the Plaistow Public Works Facility, 144 Main St. Plaistow. 9:00 AM- 12:00 Noon. Contact the Town Road Agent ( Jim Seaver) with any questions. Sheila asks if there could be a flyer posted on the Town's website and at the Town Hall.
- ✚ **Saturday, April 29- Spring Bulk Pick-up.** Sign-ups will be available beginning **April 8** and are **due no later than April 17, 2023**. Shawn explains the cut-off date is needed so Casella can set up the route for that day. He asks the public to submit their forms as early as possible. Sheila asks that any material put curbside early be covered with a tarp to prevent added water weight. Shawn explains the program works well and was developed a few years ago by Scott Borucki.

**Selectmen's Newsletter:** Sheila explains the Selectmen's Newsletter was not done last year, but has been done in the past and mailed with the June tax bills. She states she would like to continue this and outlines some of the information that is usually contained in the newsletter. Shawn notes he thought a newsletter was done last year and agrees that it should be continued. He notes the New Police Station Building Committee has asked to put something in the newsletter. Shawn suggests the letter will need wordsmithing, formatting, etc., and states the New Police Station information needs to be a priority. He asks Sheila to find a copy of the last newsletter and to begin working on it.

**FY23 Budget:** Sheila asks if the BOS can send out copies of the budget to the various departments, boards, and committees so they can know what their FY23 budgets are. Shawn explains that the changeover to the new accounting system is complete and all of this week's payroll and pay warrants came through the new system, so MRI has all the correct numbers and all the reports came out today. The BOS can now get year-to-date budget information for each account and this information can be dispersed to everyone. Sheila asks to remind everyone the Town Operating Budget is the Default Budget. She expresses her concern that boards may go over their budgets, particularly at the end of the year. Shawn reminds her that anyone going over their budget needs prior approval from the BOS because the BOS has to reallocate Town funds to cover those overages. Sheila notes the Planning Board and the Recreation Committee both went over their FY22 budgets. Shawn explains the Planning Board can go over its budget because its expenditures are offset by revenue received from the reimbursement of fees, etc. Sheila explains the Recreation Committee ordered something and didn't have sufficient funds remaining in their budget to cover those costs. Shawn confirms the Recreation Committee went over its budget and states he will look into it. Sheila notes that it was a misunderstanding.

**Audubon Society Inquiry:** Dennis states he was made aware the Town received a phone call from the Audubon Society today because they had received a call from someone in town stating that the Town Forest was being destroyed. He explains it was just a message and suggests the Conservation Commission should speak with the Audubon Society. Dennis states it is important to bring up this issue in public and asks Shawn if he has heard of any issues. Shawn states he is unaware of any issues and was not aware the Audubon Society had contacted the Town. He believes the issue is because someone is upset with the election results (of several Citizen Petition warrants) and states the Audubon Society will not find anything.

Sheila states that she was the person who called and she called as a resident and abutter because her property abuts the Town Forest. She states she called the Audubon Society because the water is being drained so much behind her and she believes the Conservation Commission is draining it. Annemarie asks if Sheila had contacted the Conservation Commission. Sheila states she did not. Annemarie asks why Sheila contacted the Audubon Society first. Sheila states she spoke with the Road Agent. Annemarie again asks why Sheila didn't talk to the Conservation Commission if she felt they were causing the problem. Sheila states that as an abutter, she didn't need to, and she went to the Audubon Society to see if they knew what was going on. Annemarie reiterates her question, noting that it is a very general one, asking if Sheila thought it was the Conservation Commission, why didn't she go to them first.

Sheila states that she didn't think of it (contacting the Conservation Commission) and didn't need to. Annemarie explains that she would go to the person before accusing them of doing something. Sheila states she didn't accuse

anyone, she just asked a question, and she had not spoken with anyone from the Audubon Society yet. Annemarie states the Conservation Commission should get involved if they are doing this and need to know what the action is for. Shawn explains there is a settlement regarding Tuckertown Rd drainage that by court order, requires the Town to keep the water at a particular level and when the water is drained it has to meet that requirement. He notes that is why the beaver dams have been put in there. Sheila states the Conservation Commission did not put the pipes in.

Shawn reminds Sheila that when she was on the Forestry Committee, she showed the BOS pictures of the water dam she was involved in and he knows the beaver dam going across was put in there. Sheila reiterates the pipes aren't there. Shawn explains the pipes set the water level. Dennis asks if the pipes were ever there. Sheila states they were there, but aren't there now. She explains how the structure of the beaver pipes is similar to a culvert. She notes that as she was driving by tonight, she noticed a pipe floating in the back. Shawn notes that with the recent large amounts of water, something may have happened.

Dennis asks if the issue is within the BOS' purview or if it needs to go to the Conservation Commission to be resolved. He notes his frustration that Sheila is on the BOS and that the Conservation Commission reports to the BOS; stating if she had a problem with the Conservation Commission, she just had to have a conversation. He explains that by calling the Audubon Society she created a message to them that doesn't necessarily need to exist. If she had spoken to the Conservation Commission and wasn't satisfied, or couldn't get satisfaction from the BOS, then she could call the Audubon Society.



Annemarie agrees that if Sheila thought the Conservation Commission was adjusting the water table, she should have gone to them first. By going to the Audubon Society, no one has had an opportunity to discuss why the water was adjusted. Sheila states that she just left a message with the Audubon Society and has not spoken to anyone there. Shawn states that Sheila needs to let the Conservation Commission know if she saw a pipe floating out there because they may not even know about it.

Sheila states the Conservation Commission should have notified the abutters if they were going to do this. Annemarie notes Sheila has the power to talk to the Conservation Commission first and that would have been a better route. Sheila states she went to the Audubon Society as a resident, not as a BOS member. Annemarie notes that even as a resident, if she knew the Conservation Commission was the one who put the pipes in, she should go to them first.

Dennis asks Sheila what she expects to get from the Audubon Society. Dennis summarizes that Sheila sees the water table dropping and doesn't believe it's legal and should not be happening. She states she has a pretty good idea of who is doing it and called the Audubon Society. He reiterates his question of what she thinks the Audubon Society will do. Sheila states she hasn't had a conversation with them so she has no idea what they will do. Dennis explains the Audubon Society will probably overreact or not react at all and his concern is that they will overreact. Shawn agrees. He notes the normal state of that area has very little water out there and the water that is there is only because of the beavers. Sheila states it is the water in the back and explains the water flows through several dams. Shawn confirms Sheila's description of the waterways. Sheila states the water behind her has never been as low as it is right now. Annemarie ask for clarification from Sheila who believes the water should be higher and she wants to know why it's not. Sheila states she's starting to see vegetation popping up. Shawn states it's supposed to be, that all the water is due to the beavers. Sheila disagrees stating that directly behind her is different and explains the pipes used to be in there keeping the water level. Shawn states the BOS will look into it and find out what is going on with the pipes and address it.

#### **IV. Town Announcements**

##### **Calendar**
