II. Budget

4195.10 Cemeteries - \$27,500: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4195.10 Cemeteries budget for \$27,500.00; motion passed.*

4312.20 Road Maintenance - \$393,372: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4312.20 Road Maintenance budget for \$393,372.00; motion passed.*

4312.30 Stormwater - \$12,500: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4312.30 Stormwater budget for \$12,500.00; motion passed.*

4312.50 Winter - \$149,000: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4312.50 Winter budget for \$149,000.00; motion passed.*

4323.20 Hazardous Waste Collection - \$5,000: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4323.20 Hazardous Waste Collection Dues budget for \$5,000.00; motion passed.*

4520.60 Maintenance of Recreational Facilities - \$9,000: *Selectman Inman made the motion, seconded by Selectman Cooper, to approve the 4520.60 Maintenance of Recreational Facilities budget for \$9,000.00; motion passed.*

III. Signature File / Minutes

Selectmen signed the Intent to Cut received from PSNH. Vice-chair Giordano asked Patty to ensure that Forestry has already cut the wood on the listed town-owned property.

Selectmen signed the 2014-23 Payroll and Vendor warrants. Selectmen signed a warrant request to the Treasurer for the reimbursement of monies from the special detail account to the town for details performed by the police department.

IV. Old / New Business

Vice-chair Giordano stated that the authority of the Forestry Committee as outlined in the RSAs is very vague. He cannot see giving the Forestry total authority, especially where issues of safety and liability are concerned.

Vice-chair Giordano discussed the input from the audience of the previous BOS meeting noting that although he agreed with Phil Emilio's statement that a Discharge of Firearms Regulation should go before the voters and be accepted as an ordinance, he had reservations if this were to put in front of the voters and voted down. The safety

issues and liability would still exist and the town would have no protection in the event of an incident. Vice-chair Giordano suggested an advisory warrant article be drafted for the people for their feedback.

Vice-chair Giordano read the announcements.

At 8:30pm Selectman Inman made the motion, seconded by Selectman Cooper, to adjourn; motion passed.
