Our meeting on November 20th was canceled because Bruce Caillouette could not present the highway budget due to a snow storm. Therefore, we moved all of the budgets from the 20th to this meeting.

Our first order of business was approving the minutes of our meeting from November 13th. George made a motion to accept the minutes as written. Ed seconded and the minutes were approved as written with 5 members approving and Tom and Shawn abstaining. Bruce and Beth Caillouette then came up to discuss their budgets.

After a short discussion of each of the budgets above they were all approved unanimously at the BOS Proposed amount. 4312.20 was increased over the original department proposal of \$427,229 due mostly to adding in enough salary line to account for a full years worth of salary for employees who came on mid year this year.

Library Trustees Mary Elizabeth Seals and Mark Sullivan along with Director Dot Billbrough, and Assistant Director Tom Billbrough Jr. re-presented additional information regarding the FY2019 Library Budget 4550.10. The trustees provided additional wage study information on an additional 6 surrounding towns as a method of establishing an area average compensation for Library personnel. After a brief discussion George made a motion for the original department proposed amount of \$261,867, Jeff Seconded the motion and the motion failed (see table below for count). Jeff then made a proposal for \$256,361 which would provide half the raise amount requested by the Library Trustees. George seconded the motion and this motion also failed by the same vote total (see table below). Shawn then made a motion for the BoS proposed amount of \$251,399. This vote passed (See table below).
