The Danville Town Hall was commissioned by warrant article in the early 1880's to replace the Old Meeting House with its lack of water, proper heating, and inflexible seating. Construction started in 1886, and the building was dedicated in January of 1887, but not without controversy. The location of the structure was vehemently opposed by the farmers of North Danville, who felt it would be of more benefit to people in South Danville. Also the design was considered too radical by some townsfolk. The outrage culminated in an aborted attempt to burn the new building down the night before the dedication.

Fortunately the attempt was unsuccessful. The structure went on to serve the town as headquarters for all of the functions of town government, and was the site of most of its political and social functions, and many of its recreational and entertainment events through the 1950's. With its stage, the second floor served as an auditorium, or a "ballroom", hosting many graduations, musical shows, recitals, and receptions. It was the home of the Danville Grange, the site of the first town library, and even housed a town jail for a short time.

In December 2000, the Town Hall was given the honor of being listed on the National Register of Historic Places. It achieved this honor on the basis that it "is associated with events that have made a significant contribution to the broad patterns of our history." It is the hope of many to restore the Town Hall's second floor, bringing the building back to its full glory and highest use. SELECTMEN'S MESSAGE

To the Citizens of Danville:

The past year has been fruitful for the Town of Danville as we entered into the new millennium. We started 24-hour police coverage for the first time ever, acquired a new advanced rescue vehicle, and passed warrant articles for a new fire truck and a library addition equipped with the latest technology. We also instituted curbside recycling and bulk trash pickups, saw our elementary school open its doors to an impressive new addition, successfully created a new Recreation program for the town's youth, and made progress in managing our town forests. We would like to take this opportunity to acknowledge some of the outstanding highlights from 2000.

For the first time in 12 years the town has a Recreation Committee. The committee successfully launched a Summer Recreation Program for children in the elementary and middle schools. The program was met with enthusiasm and entertained over 70 children over the course of six weeks. Thank you to Judy Armstrong, Dawn Weston, and Chris Green for giving much of their summer vacation to seeing the program get off the ground. We look forward to an even greater participation in 2001. We are also working to create more recreational areas in town for all residents to enjoy. Many thanks go to Peter Lewis for his donation of the Colby Pond Recreation fields to the Town of Danville. In the coming year we will begin completing this area and the Clyde Goldthwaite Recreational Facility in Rockrimmon Estates. Developing plans for 2001 include building a tennis court/basketball court, a pavilion with fire pits for picnicking, and upgrades to the playing fields to accommodate youth soccer and baseball teams, as well as for public use. Future possibilities include the creation of an ice skating rink, volleyball courts, shuffleboard and horseshoe pits and lighting for evening play and security. With the help of capital reserve funds, general funds, and many generous donations of time, money, equipment and materials we hope to provide all types of recreational opportunities for our residents. We are seeking any and all donations and volunteers who would like to help shape these recreational areas. Please contact the Board of Selectmen or the Recreation Committee if you would like to help in any way.

The Town continued to foster a sense of community with another Memorial Day Parade, and our second annual Christmas Tree Lighting Ceremony. Our thanks go out to those individuals who worked so hard to bring you those events, especially the American Legion 115, and members Jack Kelly and Fran Byron for their hard work on the parade. We are also grateful for the private donations made by individuals: Brian Delahunty for the permanent Christmas tree and Gene Bussiere for the Christmas party at the Fire Association Hall. We look forward to the continuation of these traditions.

Just this past December, the Danville Heritage Commission was notified that the Town Hall has been accepted for listing in the National Register of Historic Places. This culminates almost two years of effort by the Heritage Commission to obtain national recognition for our venerable old building that has served the town in many capacities since its dedication in 1887. We therefore thank the commission for their perseverance in attaining this national honor. Our hope is to continue to refurbish the Town Hall and bring her back to her full glory so that all town groups will have a place to meet. We thank you for your continuing support in establishing a capital reserve fund for this purpose.

We would sincerely like to thank all the other residents in town who willingly give their time to the many other volunteer boards that exist for the good of our community: the Conservation Commission, the Planning Board, the Zoning Board, the Budget Committee, the Forestry Committee and the Cable Committee.

It is also through the hard work of our Town's employees that we achieve success. With the help and recommendations this past fall from a special Wage and Salary Committee, we have instituted a plan to bring compensation for Town employees to an equitable market level in the year 2001. And special thanks go to Beth Udelson, Selectmen's Administrative Assistant and Debbie Paine, Treasurer, for their conscientious work and for establishing procedures to achieve accurate record keeping.

As you will see in the financial reports presented here within, we ended the year 2000 with a surplus. Much of this under-expenditure is due to projects that could not be started in 2000 but will commence in 2001. These funds have been encumbered for their intended purposes. Other items contributing include funds for the evening full time police officer that are to be expended over the next two years, but had to be appropriated in the year 2000. With the thorough and diligent help of the Budget Committee, we have striven to put forth as accurate a budget as possible to prevent inflating our taxes in the year 2001.

As always there are endless opportunities in town to promote change. We encourage all residents to get involved in our town. Earl Sweet, Chairman Robert Kent and John Russo

4) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 13th only)

AMEND ARTICLE II., <u>Definitions</u>, J., to read:

HOME OCCUPATION

Any activity carried out for gain by a resident and conducted as a customary, incidental, and accessory use in the resident's dwelling unit or other buildings on the resident's property

AMEND ARTICLE IV., <u>Permitted Uses and Restrictions</u>, A.2.e.iii., to read

Any changes made to the residential lot as a result of this accessory use that affect the external appearance of the property, the dwelling or any accessory building, shall be in keeping with generally accepted good residential architectural practices and styles and shall conform, in general, to the surrounding neighborhood's architecture.

AMEND ARTICLE IV., <u>Permitted Uses and Restrictions</u>, COMBINE A.2.e.vii and A.2.e.viii to become ARTICLE IV.A.2.e.vii.

ADD to ARTICLE IV., <u>Permitted Uses and Restrictions</u>, A.2.d., a new bullet to read:

Home occupation is conducted solely in the dwelling unit and off-site. (RECOMMENDED BY THE PLANNING BOARD)

(RECOMMENDED BY THE PLANNING BOARD)

6) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 13th only)

AMEND ARTICLE V., Supplemental Regulations, G.,

EXCAVATION, third paragraph to read:

The proposed excavation will be conducted to a depth not greater than three (3) feet above the seasonal high-water mark, unless the applicant can demonstrate the excavation will not adversely affect water quality and is subject to verification by an independent engineer at the applicant's expense.

AMEND ARTICLE V., <u>Supplemental Regulations</u>, G., EXCAVATION, fourth paragraph to read:

A formal application with all applicable State approvals must be submitted by the applicant to the Regulators for their review. The Regulators will review the application in accordance with the requirements of RSA 155-E, the Town of Danville Excavation Regulations, and any other applicable Danville Zoning Regulations.

THIS ARTICLE V. TO BE EFFECTIVE UPON PASSAGE AT TOWN MEETING ON MARCH 13, 2001.

8) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 13th only)

ADD to ARTICLE XII., <u>Telecommunications Facility</u> <u>Ordinance</u>, G.2.a., to read:

(1) Noticing of abutters shall be in accordance with the Town of Danville Site Plan Review Regulations. (2) Additional notification shall be required to be given to any other New Hampshire municipality within a twenty (20) mile radius. This notification shall include sending a letter to the governing body of the municipality within the twenty (20) mile radius detailing the pending action on the application and shall also include publishing a notice in a newspaper customarily used for legal notices by such municipality within the twenty (20) mile radius, stating the specifics of the application, the pending action and the date of the next public hearing on the application. When the Heritage Commission votes to approve or disapprove an application or deny a motion for rehearing, the minutes of the meeting at which such vote is taken, including the written decision containing the reasons therefore, shall be placed on file in the Town Clerk's/Selectmen's office and shall be made available for public inspection within one hundred forty-four (144) hours of such vote. This appropriation is in addition to Warrant Article #27, the operating budget article.
 (RECOMMENDED BY THE SELECTMEN)
 (RECOMMENDED BY THE BUDGET COMMITTEE)
- 22) To see if the Town will vote to accept the State portion of Colby Road, only after the following criteria have been met by the State of New Hampshire, including, but not limited to the following: Starting from Route 111-A, the island would have to be removed to make a "T" intersection and repair and/or installation of the appropriate drainage; the installation of hot top swales on both sides of the hill corners and, where necessary, on the hill, west of the bridge; all repairs are to be made to the bridge, including widening of the right-of-way and new guardrails, etc; the grinding of all of the existing hot top from Route 111-A to the end of the State maintenance area, grading of the roadway and installation of new hot top of two and one-half inches (2 ¹/₂") with adequate crown to the existing width of the roadway. (NOT RECOMMENDED BY THE SELECTMEN)

The income from the Parsonage Lands, so called, shall be designated to the maintenance of the Old Meeting House. INDEPENDENT AUDITORS – 1999 REPORT

To the Members of the Board of Selectmen Town of Danville Danville, New Hampshire

We have audited the accompanying general purpose financial statements of the Town of Danville as of and for the year ended December 31, 1999 as listed in the table of contents. These general purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these general purpose financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The general purpose financial statements referred to above do not include the general fixed assets account group, which should be included in order to conform with generally accepted accounting principles. As is the case with most municipal entities in the State of New Hampshire, the Town of Danville has not maintained historical cost records of its fixed assets. The amount that should be recorded in the general fixed assets account group is not known.

In our opinion, except for the effect on the financial statements of the omission described in the preceding paragraph, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Danville as of December 31, 1999, and the results of its operations and the cash flows of its non-expendable trust funds for the year then ended in conformity with generally accepted accounting principles.

The Unaudited Supplementary Information on page 19 is not a required part of the basic financial statements, but is supplementary information required by the Governmental Accounting Standards Board. We have applied certain limited procedures which consisted principally of inquiries of management regarding the methods of measurement and presentation of the supplementary information. However, we did not audit the information and do not express an opinion on it. In addition, we do not provide assurance that the Town of Danville is or will become year 2000 compliant, the Town of Danville's year 2000 remediation efforts will be successful in whole or in part, or that parties with which the Town of Danville does business are or will become year 2000 compliant.

Our audit was made for the purpose of forming an opinion on the general purpose financial statements of the Town of Danville taken as a whole. The combining and individual fund financial statements listed as schedules in the table of contents are presented for purposes of additional analysis and are not a required part of the general purpose financial statements of the Town of Danville. Such information has been subjected to the auditing procedures applied in the audit of the general purpose financial statements and, in our opinion, is fairly presented in all material respects in relation to the general purpose financial statements taken as a whole.

BUILDING INSPECTOR – 2000 REPORT

FIRE DEPARTMENT – 2000 REPORT

Thanks to the 1999 vote of the Townspeople, we received our new rescue vehicle this year. The new rescue vehicle is now fully stocked and in service to support rescue activities as well as patient care and transport at the Advanced Life Support (paramedic) level.

The Townspeople also voted this year (2000) to allow the Fire Department to purchase a new fire engine. Unfortunately, due to a lawsuit by several NH Towns regarding what is considered to be the required majority vote on bond issues, we were unable to acquire the bonds necessary for the purchase. We are still awaiting the verdict from the NH Supreme Court on this matter, as well as the input from the NH Department of Revenue Administration as to how to proceed.

We hosted 33 training events this year in support of our continued emphasis on education in both emergency medical services and fire suppression. Several department members have also taken it upon themselves to further their education by taking advanced fire fighter and Emergency Medical Technician courses in addition to the training offered by this department.

Our call volume in 2000 was up slightly over 1999, including a 16.5% increase in emergency medical calls. The call summary is as follows:

POLICE DEPARTMENT - 2000 REPORT

Last year we introduced 24-hour patrol coverage for the first time in Danville. Four new officers were hired and the Police Department is now at full staff for the first time in many years. A second full time officer was hired and is being funded primarily from a Federal Grant award received through the COPS Universal Hiring Program. A midnight shift was created and we quickly noticed the benefits of this additional patrol shift. Response time to emergency calls was greatly reduced and a reduction in early morning speed related offences was noticed within the first two months. Although we continue to receive complaints of some speed related incidents, the numbers appear to be decreasing.

Thankfully, there was no increase in reported burglaries last year. I credit this in part to increased patrol coverage and neighbors watching out for each other. We were, however, inundated with criminal mischief complaints -- most, of which were mail-box vandalism that occurred during the summer months. After a lengthy investigation, a major drug ring was broken last year with the assistance of Federal, State, County and local authorities. Several arrests were made and a distribution hub in Southern New Hampshire and Massachusetts was dismantled.

With the addition of many new officers and recent changes in legislature, we are planning to enhance our in-house training program. Currently, officers must attend 8 hours of approved training annually to maintain their state certification as police officers. We are hoping to more than double that number for 2001. Some of our officers are already enrolled in continuing education. I would like to particularly recognize Lieutenant Leo Beauchamp who received a Juris Doctrine in Law – graduating from the Massachusetts School of Law in Andover in June 2000.

We are planning to reintroduce "Project Charlie" at the elementary school this year. This interactive program encourages positive self-esteem and helps students deal with peer pressure issues. Members of the police department will teach the class to second graders.

Once again we sponsored the annual Christmas Tree Lighting Ceremony. This year, a permanent tree was graciously donated by Brian Delahunty and planted in the center of town near the Veterans War Memorial. Many residents braved the extreme cold that day to take part in the festivities. The students and staff of the Danville Elementary School handcrafted all the ornaments and helped decorate the tree. Immediately following the ceremony, pizza and refreshments were served to everyone at the Association Hall. Songs of the season were performed by the band "Hawkin's Way" while Santa visited with the children and passed out gifts. I would like to offer additional thanks to Gene Bussiere, the Danville Recreation Committee, Casey Clark, the Bielecki family, Allan Hess and Michael Comeau of Video Tours of New England for helping make this event a huge success.

Lastly, I would like to thank my staff, who are some of the finest men and women I have had the pleasure to work with. Despite the fact many of them had to endure tragic personal loss last year – they remained focused and dedicated to their professional commitments.

COLBY MEMORIAL LIBRARY - 2000 REPORT

We had another very busy year. We have registered 175 new patrons. There were 8,360 patron visits and a circulation of 15,715. We added 1,177 books, 56 audios, 6 CDs, and 35 videos to the collection.

Gloria Maduzia was named Trustee of the Year by the New Hampshire Trustees Association in May. The New Hampshire Library Trustees Association Awards Committee chose her as the winner based on the endorsement submitted by her fellow trustees. She was nominated for her ability to provide information regarding library technology, library laws, and pay scales, as well as her hard work and dedication in getting support for the addition to the library.

We have family passes for the Museum of Science in Boston and to the American Independence Museum in Exeter. Please come to the library to borrow the passes. We also have public access to the Internet. If you would like to send an e-mail message to the library to renew or request a book send it to colbylibrary@ttlc.net.

We have a new database available to the public at the library and it can be accessed from home PCs via Internet. It is called Proquest Discovery. It provides access to 2,300 periodicals, 1,500 of which are full-text. In addition there are 5 national newspapers, and a good general reference database, funded by the State of New Hampshire. Please come to the library for more information.

In January we received 10 new children's picture books from the Brownstone Foundation in New York City. Reading Cats and Dogs was the slogan for our summer reading program. One hundred twenty children participated in this program and read 1,000 books. We had the Little Red Wagon from the University of New Hampshire perform at the kick-off program. In August we had our annual picnic and children who had participated received certificates and prizes. Bob Riordan's magic show concluded our summer program.

This year the warrant article for our library addition passed. Thank you for recognizing our space needs and supporting our efforts. However, we couldn't begin construction due to a statewide challenge of the law regarding bond issues. We are waiting for the Supreme Court to make a decision.

We finished entering all materials into the computer database and have been circulating our collection using the computer system.

Thanks to all the people who donated books, videos, magazines, and audio. Thanks to the Friends of the Library for their continued support. They held a yard sale this year, helped to pay for the summer program and purchased passes to the American Independence Museum in Exeter. Thanks also to Dave, Nancy, Justin and Jamie Daniels and Tim and Tommy Billbrough for their help moving books to the book sale.

Library hours are Monday and Tuesday 1-8 P.M., Wednesday 9:30 A.M.-12 P.M., Thursday 11 A.M.-8 P.M., & Saturday 9:30 A.M.-1 P.M. Pre-school story hour is held on Thursday at 10 A.M.

PLANNING BOARD - 2000 REPORT

While the number of subdivision applicants that came before the Board continued to be fairly small, we have seen increased activity recently. We have also begun seeing applications for small commercial development in Danville.

In 2000, the Board continued its work to ensure that all approved subdivisions were in the tradition and character of the existing Danville community. The proposed changes to Danville's Zoning Ordinance that appear on the 2001 Town warrant are intended to help preserve our Town's unique character. We ask for your support.

In 2001, the Planning Board hopes to update the Town's Master Plan. We are seeking a grant from the Rockingham Planning Commission to help in this endeavor.

Finally, the Board wishes to thank the residents of Danville for the interest they have shown in Town planning and we ask for your continued support in the future.

CONSERVATION COMMISSION – 2000 REPORT

In 2000, the Conservation Commission began a wetlands inventory and evaluation project. The goal of this project is to comparatively evaluate and prioritize wetlands in Danville. The main objective of the project is to determine which wetlands, if any, deserve a higher level of protection in order to maintain the Town's flood control capacity, water quality and purification processes, groundwater recharge, shoreline stabilization, fish and wildlife habitat and recreation. The Commission received free classroom instruction and in-field training in the "Method for the Comparative Evaluation of Nontidal Wetlands in New Hampshire" from the University of New Hampshire's Cooperative Extension Program.

The Conservation Commission also worked with the Planning Board and the Selectmen in reviewing and commenting on Terra Realty Trust's graveling permit conditions regarding the use of changes to Tuckertown Road, wetland issues and construction of ponds. We also reviewed and provided comments to the Planning Board on two proposed subdivisions, a lot line adjustment and proposed excavation regulations for the Town.

Other activities this past year included reviewing and providing comments on five dredge and fill permit applications to the New Hampshire Department of Environmental Services Wetlands Bureau. We also reported four separate wetland violations to the Department and worked with both the State and the property owners to resolve them. Some members of the Commission attended training sessions in both wetlands delineation as well as identification of vernal pools. Finally, we worked with the boy scouts to identify and improve the beginning of the Class A trail which runs from the Clyde Goldthwaite Recreation Area to the Rockrimmon Trail.

The Conservation Commission meets the first Wednesday of each month at 7:30 PM at the Town Hall. Meetings are open to the public and we encourage the public's attendance and participation. Persons interested in becoming a member should submit a letter of interest to the Selectmen.

HERITAGE COMMISSION – 2000 REPORT

The Heritage Commission is pleased that several community projects have been completed this year. In March the Danville voters approved a warrant article adding "the Sandilands property", to the historic district. This 40-acre parcel of land was once a part of the Page/Peaslee family's "Great Meadow." It borders the south side of Tuckertown Road and was purchased in 1999 with funds from Danville's Conservation Fund. The Town now owns and has protected a substantial amount of land on both the south and north sides of Tuckertown Road. Voters this year also overwhelming approved a warrant article supporting creation of New Hampshire's Land and Community Heritage Investment Program. The program became state law in May and for the first time, state funds are available for historic and cultural preservation and conservation.

In May the Commission began working with Boy Scout Weston Forsblad on suggestions for a three-dimensional map showing historic sites in Danville. This was an Eagle Scout project for Weston. On December 2 the map was mounted on the front porch of the Town Hall. Free brochures developed by the Heritage Commission that explain the sites are available in a box near the display. Weston's project will help residents and visitors locate and learn more about some of Danville's special historical places.

At the request of the Selectmen, the Commission developed detailed recommendations to renovate and restore the second floor of the Town Hall so it will be functional again but retain its unique historic character. Suggestions include phases for restoration and a lift location proposal. The recommendations were presented to the Selectmen in the fall. The Commission also contributed a package of photographs, historic district information, research and other historical information for the Time Capsule which the Selectmen are planning to bury sometime this year.

We are currently working to update the list of historic resources and future goals of the historic section for the Master Plan. Ongoing also is the work to archive the Town's old records in the safe of the Town Hall. All of the materials have now been inventoried and we are addressing safe and proper storage. We have made recommendations to the Selectmen for humidity control and possible scanning of these historic documents into a computer for safety and easier viewing by the public. We hope to complete these two projects by spring. The Commission's bulletin board projects at the Town Hall and local educational newspaper articles are also ongoing. We welcome new material, photographs or stories. Please contact us if there is something you would like to share about Danville's history.

We would like to acknowledge the contributions of Diane Howes during nearly five years of service on the Heritage Commission. Because of her efforts the Town now has a substantial collection of photographs and material on Danville's historical sites, homes and burial grounds.

Finally, we are proud to announce that Danville's Town Hall was officially listed on the National Register of Historic Places as of December 1, 2000. It was selected for listing on a criteria that the property is associated with events that have made a significant contribution to the broad patterns of our history. Commission Member Bill Gard worked arduously on this project for more than a year with the assistance of Christine Fonda of the New Hampshire Division of Historic Resources. We would like to thank Paul Collins and Janie Sigilman for their help with important research, measurements and assistance that was needed for the application. This is a wonderful honor for our Town Hall.

The Town Heritage Fund, established by the voters in 1997, is still in place for bequests or donations to help further the identification, preservation and protection of Danville's heritage and historic resources. The Heritage Commission meets on the second and fourth Wednesdays of each month at 7:30 P.M. and most meetings are televised. There are several openings on the Commission. Anyone wishing to join may contact the Board of Selectmen.

FORESTRY COMMITTEE REPORT - 2000

The Town of Danville is fortunate to own nearly 500 acres of forestlands for public use. In 1954, the town voted to legally designate the "Peaslee land" of approximately 140 acres as "Town Forest". To manage the Town Forest, the Danville Board of Selectmen appointed a three member Forestry Committee.

To enhance and complement the existing Town Forest, a warrant article is proposed in 2001 to officially designate an additional 13 town owned properties of 369 acres as "Town Forest."

New Hampshire defines the purpose of a Town Forest is "to encourage the proper management of timber, firewood and other natural resources through planting, timber stand improvement, thinning, harvesting, reforestation, and other multiple use programs consistent with the forest management program."

Because the town owned properties have not been formally surveyed, the Committee is working to locate and clearly identify the outside bounds of the approximately 14 town properties that will be part of the Town Forest. Part of this work also includes wide-ranging deed research and an understanding of the composition of the forest and its wildlife.

In addition, the Committee is working with the Rockingham County Forester to assist with an assessment of the general condition of the forest, various management options, and recommendations on how to put together a formal management plan for the forest.

Because the forest is a complex, living ecosystem that is always changing, the committee will rely on the professional services of a licensed forester to design a written forest management strategy that promotes a full spectrum of benefits to the town.

A formal long term Forest Management Plan is essential to encourage the health and life of the forest for many generations to enjoy. Our forest land is part of the future. What we do to our land affects trees, birds, animals, plants and all living things in the forest. The Forestry Committee's goals are in concert with the Conservation Commission and the Heritage Commission to preserve and protect Danville's valuable land and wildlife assets through responsible management practices.

HIGHWAY DEPARTMENT – 2000 REPORT

The trimming of roadside brush continued this year, with the purchase of a brush chipper. This year we were also able to have the roadside mowing done.

We continued the reclamation project on parts of Long Pond Road, with the grinding of the old road, re-grading the road surface and then resurfacing. This project will be continuing yearly on different roads and areas throughout the Town. The bridge projects on Sandown Road and Johnson Road have begun. An engineering firm has been chosen and the initial test borings have been done.

The end of 2000 winter season has been busy. We have had three storms. A six inch snowstorm, an icy two inch snow storm and a twelve inch snow storm. The Highway Department wants to remind all citizens that it is illegal in the Town of Danville to plow, shovel or snow blow snow onto or across any town road. This ordinance carries a fine of One Hundred (\$100.00) Dollars to the homeowner. Please make note of this when you are clearing your driveways and walkways. Also please make note that no vehicles or other property may be placed in the Town's Right of Way during winter maintenance. If this occurs you are subject to a fine as well as having your vehicle towed. On rubbish pickup days, during snow storms or predicted storms, please keep your rubbish barrels in your driveways. Thank you for all of your cooperation.


