Resident Caleb Chretian's mother Carol Chretian contacted Ms. Shogren directly about the Tucker Town Walking Trail cleanup and that certified letters need to be mailed out to the property owners whose land in the town abuts the westerly side of Caleb Dr. to the Sandown line. Ms. Chretian advised that she will draft a copy of the letter and return it to Ms. Shogren.

Janet from the Selectmen's office received a request to buy the Woodstove at the entrance of the Town Hall. After much discussion it is in the Town's best interest not to sell as it artifact that holds limited value of around \$450. It should be kept at/with the Town Hall at this time.

Chairman O'Neil stated the Comcast renewal was received and suggested a public hearing be held on 06/13/16 at 7:00 pm. Ms. Shogren stated that she would get the meeting date published in the paper.

Chairman O'Neil stated that Selectman Johannesen was not on payroll this week due to an administrative error of overpayment in the previous pay period; however this has since been rectified. Selectman Johannesen advised that this is not an issue and she did not know about the error until she reviewed the warrants.

Chairman O'Neil and Ms. Shogren have spearheaded the June 1st Property and Liability renewal for the Town. At this time three companies have given similar quotes. Ms. Shogren advised that there isn't much time however she will check in on this.

Vice-Chair Giordano advised that the roads at the Rock Rimmon Association will not be wide enough for the trash trucks to pick up receptacles curbside. The board advised that the Association is dealing directly with Casella in regards to this issue.
