Minutes of our December 12th, 2017 meeting

Vice-chairman, Jeff Steenson called this meeting of the FY2018 Danville Budget Committee to order at 7:33 PM, with the following members present:

Our meeting started with a motion by Dave, which was seconded by George, to correct the minutes of our meeting from November 28th for budget 4234.10 Waste Disposal and Recycling to \$322,279. The budget was stated in the minutes as being approved in the amount \$327,279. After approval, Dave made a motion to accept the minutes as amended. Both motions carried as follows below:

Next, Chris Tracy was present to discuss the FY2018 proposed Voter Registration Budget (Account# 4140.20) and the FY2018 proposed Town Clerk Budget (Account# 4140.10). During our review, Dave made a motion to accept the FY2018 Voter Registration Budget (Account# 4140.20) in the amount of \$19,927. Kim seconded the motion and the motion carried unanimously. George then made a motion to accept the FY2018 Proposed Town Clerk Budget (Account# 4140.10) in the amount of \$88,146. Kim seconded the motion and the motion carried unanimously.

We then reviewed FY2018 proposed Town Forest Maintenance (Account# 4619.9). After Dave commented that \$450 was spent on pond levelers this year and that we should account for the likelihood that money will need to be spent next year for this line item, George made a motion to accept this budget in the amount of \$1110. Ann seconded the motion and the motion carried unanimously.

The next budget reviewed was FY2018 proposed Personnel Budget (Account# 4155.9). Dave made a motion to accept this budget in the amount of \$333,851. George seconded the motion and the motion carried unanimously.

FY2018 proposed Insurance Other (Account# 4196.10) was then reviewed next. George made a motion to accept this budget in the amount of \$35,115. Kim seconded the motion and the motion carried unanimously.

We then reviewed the FY2018 proposed Community Center Budget (Account# 4194.20) at the end of our review George made a motion to accept the budget in the amount of \$20,470. Ann seconded the motion and the motion carried as follows below:

The FY2018 proposed Building Inspector Budget (Account# 4241.10) was then reviewed. After review, George made a motion to accept this budget in the amount of \$2600. Kim seconded the motion and the motion carried unanimously.

The following FY2018 Warrant Articles were then discussed. All of the below passed with a unanimous 5-0 vote:

Article 2018-xx Purchase of New Fire Department Rescue/Pumper Vehicle

To see if the town will vote to raise and appropriate Four Hundred Fifty Thousand Dollars (\$450,000) to purchase and equip a Rescue/Pumper vehicle which Two Hundred Ninety Thousand Dollars (\$290,000) will be withdrawn from the Fire Dept. Capital Reserve Fund for Future Fire Dept. Vehicle Purchases capital reserve fund to replace E2 Engine/Pumper and to name the Board of Selectmen to be the agent to expend these funds. The remaining One Hundred Sixty Thousand Dollars (\$160,000) will be raised through taxation.

We also have a similar question we would like to pose to the Fire Ward's regarding a cap on the Protection of Personnel Equipment Capital Reserve Fund.
