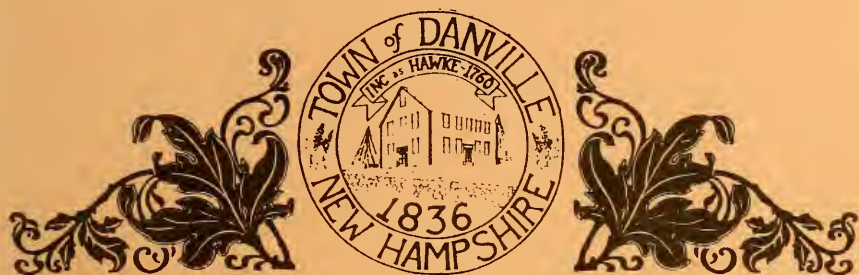

DEDICATION

Approximately one month after moving to Danville, **BILL MACE** saw and/or heard a fire truck moving down Main Street, and said something to the effect of "They're all volunteers in Danville, I'll go and see if there is something I can do." And that was the start of his getting involved with the Town of Danville.

He was elected Auditor in 1961 as a write-in candidate, and one of the votes counted for him was "Billy Mace's father." Bill served in that position until 1976, when he was appointed Treasurer. He stayed on as Treasurer until 1993 when he was defeated.

In the meantime, he served many years on the Budget Committee--way back when they only had two meetings--the preliminary and public budget meetings--upstairs in Town Hall.

He became an active member of the Danville Fire Department, and then the Danville Fire Association--and worked hard with all the other members back in the late '60's and early '70's to get the Fire Hall built. All members canvassed the Town looking for donations--be it actual cash, trees to be cut down for lumber, meals to feed them when they were out in the woods doing the actual cutting--or hammering, finishing or staining--it was one big endeavor that really brought out the best in all residents of Town.

Do you remember the night the late Carroll Kimball and Bill collided, just north of our driveway, and they landed in the field south of Gauvin's house? When the Police arrived to investigate they couldn't find the occupants! Not being injured, dedicated firemen that they were, they picked themselves up, hustled to the old Station 1, and were already on their way to the fire!

No one can ever say Bill did not have the best interest of DANVILLE at heart whatever he did or whatever he said--he may not have sugar-coated what he was saying, but he always spoke his mind with Danville's best interest at heart.

REPORT OF THE TRUSTEES OF THE TRUST FUNDS

Danville, N. H. Year ending Dec. 31, 1993

Considering only those funds held for the entire year, the yield on investments for 1993 was 4.0%. This compares with 5.4% for 1992 and 7.3% for 1991. The drop in interest rates is having a serious effect on our income.

New cemetery lot perpetual care funds were established for: Robert Meaney, Frank E. and Sandra C. Fortier, Mary H. and Ernest J. Lebel and Richard and Christine Goldthwaite.

\$5,000. voted at the March town meeting was added to the Colby Memorial Library Capital Reserve Account.

\$4,712. was added to the Fire Truck Capital Reserve Acct. from the sale of two old vehicles.

A capital gain of \$1,560.77 was realized for Common Fund #1 by the sale of the Philadelphia Electric Co. Bond and the investment of the proceeds in Vanguard's Windsor II Mutual Fund.

Payments to the Town included \$64,312. for the last payment on the new fire truck; \$2,000. for work in the town forest, \$977.82 for cemetery care, and \$402.73 from the Recreation Comm. Capital Reserve Acct. for improvement to the playing fields.

William Boucher II was the recipient of the American Mechanics Citizenship and Patriotism award this year. Unfortunately, declining interest rates have reduced this prize to \$24.69.

\$1,042.04, the income from the Eaton and March Funds, was paid to the Timberlane Regional School District toward Danville's share of school costs. In 1926 the income from these funds paid one fifth of the school expenses, but school costs go up and trust funds don't.

This year the trustees received two funds set up years ago by Lester A Colby. One for the Colby Memorial Library and one for the cemeteries. The bank that had been managing these funds turned them over to us because interest rates have declined to the point where the fund's income doesn't cover their administrative fees. Our fees are much lower.

We are now managing 112 cemetery care funds, 22 trust funds, and 5 capital reserve accounts for a total of 139.

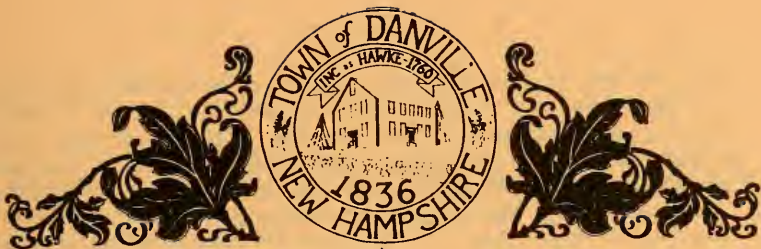

WARRANT AND BUDGET 1994

To the Inhabitants of the Town of Danville in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Danville Fire Association Hall in said Danville, on Tuesday, the Eighth day of March, next at 10:00 o'clock in the forenoon to act upon the following subjects.

1. To choose all necessary Town Officers for the year ensuing. (By ballot)
2. To see if the town will vote to accept the provisions of RSA 31:95-b providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the selectmen to apply for, accept and expend, without further action by the town meeting, unanticipated money from a state, federal, or other governmental unit or a private source which becomes available during the fiscal year.
3. To see if the town will accept the provisions of RSA 202-A:4-c providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the public library trustees to apply for, accept and expend, without further action by the town meeting, unanticipated money from a state, federal or other governmental unit or a private source which becomes available during the fiscal year.

4. To see if the town will vote to authorize the board of selectmen to accept gifts of personal property which may be offered to the town for any public purpose, pursuant to RSA 31:95-e. The Selectmen must hold a public hearing before accepting such gift, and the acceptance shall not bind the town to raise, appropriate, or expend any public funds for the operation, maintenance, repair, or replacement of any such personal property.

5. To see if the town will accept the provision of RSA 33:7 providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the selectmen to issue tax anticipation notes.

6. To see if the town will vote to authorize the selectmen to convey any real estate acquired by the town by tax collector's deed indefinitely, until specific rescission of such authority. Such conveyance shall be by deed following a public auction, or the property may be sold by advertised sealed bids, or may otherwise be disposed of as justice may require, pursuant to RSA 80:80.

7. To see if the town will authorize the selectmen to transfer tax liens upon real estate acquired by the town as the result of the execution of the real estate tax lien by the Tax Collector for non payment of taxes, until specific rescission of such authority.

8. To see if the town will vote to delegate to the Selectmen the authority to accept dedicated streets. The selectmen may only accept a street which has first been approved by the planning board as part of a subdivision plat or site plan or street plat. In addition the street must have been "dedicated" by the landowner, meaning the land owner has indicated some intent to have the town take over the road. The Selectmen must also hold a public hearing on the proposed acceptance before voting.

9. To see if the town will vote to authorize the board of selectmen to accept, on behalf of the town, gifts, legacies, and devises made to the town in trust for any public purpose as permitted by RSA 31:1.

10. To see if the Town will vote to raise and appropriate \$20,000. (Twenty Thousand Dollars) to be added to the Capital Reserve Fund for Future Fire Truck Purchases. (Recommended by Selectmen)

11. To see if the town will vote to authorize the Fire Wards to enter into a "District Hazardous Material Mutual Aid System" pursuant to RSA 154:30-a.

12. To see if the Town will raise and appropriate the sum of \$3500. (Thirty-five Hundred Dollars) for the support of the "District Hazardous Materials Mutual Aid System".

(Recommended by Selectmen)

13. To see if the Town will vote to adopt the following ordinance: Control and containment of hazardous materials. (Complete ordinance is attached and on file with the Town Clerk).

14. To see if the town will vote to raise and appropriate the sum of \$1,000. (One Thousand Dollars) for construction and/or renovation to the ball field known as the Kenneth R. Day Memorial Field and withdraw these funds from the Recreation Capital Reserve Fund.

(Recommended by Selectmen)

15. To see if the town will vote to raise and appropriate the sum of \$3,000. (Three Thousand Dollars) for fencing and installation of such fencing at the ball field known as the Kenneth R. Day Memorial Field, and withdraw these funds from the Recreation Capital Reserve Fund.

(Recommended by Selectmen)

16. To see if the Town will vote to accept as Town Roads: Cote' Drive, Sweet Street, Candy Lane, Lollipop Lane, Caramel Drive and Milky Way; in addition to 1150' (Eleven Hundred and Fifty Feet) of Huntington Hill Road Extension, in a southeasterly direction from the intersection of Old Johnson Road and Huntington Hill Road Extension; and Danielle Street.

17. To see if the Town will vote to raise and appropriate \$73,000. (Seventy-three Thousand Dollars) to build and equip a 26' by 50' addition to the Colby Memorial Library, and to withdraw such funds from the Colby Memorial Library Building Fund.

(Recommended by Selectmen)

18. To see if the Town will vote to raise and appropriate the sum of \$16,500. (Sixteen Thousand Five Hundred Dollars) (Annual cost of \$18,000. salary plus the cost of a limited benefit package, to hire a full time Police Officer. (By petition)

(Not recommended by selectmen)

19. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.

20. To transact any other business that may legally come before the Meeting.

The polls will be open from 10:00 a.m. to 7:00 p.m.

The second session of the Business Meeting will be held at 1:00 p.m. on Saturday, March 12, 1994, at the Fire Association Hall.

REPORT OF PATAC COMM. - 1993

PATAC was formed with volunteers from NH towns that neighbor Plaistow. The initial goal of PATAC was to bring commuter rail service to Plaistow. Although PATAC now has much broader goals, it continues to be made up of volunteers and does not receive any funding or dues from any local, state, or federal agencies. Our sole source of funding is through our annual "Christmas Tour of Boston".

Plans started in 1991 to develop an intermodal Park and Ride facility in Plaistow are now well underway. The site for the Park and Ride lot in Plaistow has been selected; it will be on Westville Road. It will ultimately let commuters transfer easily between different modes of transportation. In Plaistow's case the modes will be bus, car, train and possibly a few pedestrians or cyclists.

The Rockingham County Planning Commission, with help from PATAC, brought the necessary parties together that allowed the COACH Co. to apply for, and receive, CMAQ funding. This funding will establish a commuter bus to Boston starting in Epping and continuing south on RT 125 to Kingston and Plaistow where it will continue non-stop to Boston. In fact the Park and Ride lot will be first used as a bus stop, before it becomes a true Park and Ride lot. When commuter rail service is established, the bus riders will then transfer from the bus to the train for an even speedier commute to Boston.

The NH Dept. of Transportation will develop the Westville Road site to enhance it from just a bus stop to a Park and Ride lot to a Park and Ride lot with a commuter rail station similar to the one that exists at the Bradford Station. PATAC, the Plaistow Planning Board and the Plaistow Board of SElectmen will all have a great deal of input for the State DOT as plans progress for the Park and Ride.

PATAC will continue to work towards its goal of bringing intermodal transportation to all surrounding commutities. We wish to thank the voters and residents for their continuing support.

1992-1993 TOWN FOREST REPORT

In 1992, only two people cut wood--in 1993 only one did.

So, thanks to the Lester Colby Forest Fund for roads in the Town Forest, the Tucker Town Road was gravelled the entire length.

We also increased our staff by hiring Carolyn Birr as a substitute librarian. Carolyn is a certified Librarian and comes to us with much experience and enthusiasm. Please join us in welcoming Carolyn to our staff.

Unfortunately, due to an increased number of other responsibilities, Dale Marcelonis resigned as Library Trustee this year. The remaining Library Trustees, with input from the Library staff, made a recommendation to the Selectmen that Nancy Sheridan be appointed to fill the vacated position. The Selectmen acted upon the recommendation and Nancy has been appointed as our third Trustee. Our thanks to Dale for her time and efforts.

After receiving approval at the March town meeting, a computer and library software package were purchased this year. This has kept the library staff very busy entering the library holdings into the database, and printing the barcodes. Special thanks go to Ruth Keighley and Tommy Billbrough who spent many hours placing bar-code protectors on thousands of books and other materials. Thanks also to Dick Mitchell for donating a computer and software, which will eventually be used when we have more room.

Well, on the subject of more room, a building needs committee was formed and will give a report at the 1994 town meeting regarding a proposed addition to the library. We hope that each of you will show your support of the library at the next town meeting by allowing us to go forward with our much needed expansion.

Children's programming continued to meet with enthusiastic support this year. This program, entitled "Ketchup on Your Reading", was well attended with 25 children participating weekly. The children learned to speak some French words and phrases, played games, listened to stories and did some craft projects. A professional storyteller entertained the children at the Town Hall during a picnic lunch at the conclusion of the program.

This year we received a generous gift from Miriam Sargent in memory of her mother Miriam Colby Sunderland, who grew up in Danville. Mrs. Sunderland was the niece of Lester Colby (who

donated the land and moneys for the present library), and the sister of the late Alden Colby. This donation will be used to purchase both childrens and adult books.

Thanks again to the Friends of the Library who continued to support the library with gifts of videos and other materials.

As shown above, the requests for help are increasing as our Town continues to grow at a steady pace. Over 30 new homes have been occupied during the past year.

As our society becomes concentrated and complicated, there are more demands placed upon us to insure that we may live safe and healthy in a clean environment. At Town Meeting you will be asked to approve three warrant articles relative to control of hazardous materials as mandated by State and Federal requirements to insure a safe future.

At this time we are attempting to acquire more up-to-date military vehicles to replace the 1952 forestry units that are presently in service. This will make the cost of the chassis minimal. The construction of a tank and body with the adaptation of some of our present good equipment will cost much less than an outright new commercial purchase--in effect the savings of more than \$100,000. could be realized.

By using modern manmade materials and proper design, the tank/body assembly should outlast more than one truck-life cycle, not effected by rot, rust, corrosion or premature breakdown as with more commonly used construction materials.

This year we are asking for a continued contribution to the capital reserve for "future fire truck purchases".

The new breathing apparatus purchased by the joint effort of the Town and the Fire Association is in service and is functioning perfectly.

There is a large scale epidemic of rabies in the United States and it is not only raccoons that are infected but many other types of animals large and small. If you see any animal that is acting strange, call us.

The Department sponsored two rabies clinics in 1993 and are hoping to hold two this year for cats and dogs. For all other animals contact your Vet or us for info as to what does or does not need the rabies shots. State laws say that any law officer may go house-to-house and check for rabies certificates for all your dogs and cats.

Reminder: all dogs six months and older must be licensed per State law, and if not, fines and court action will be taken.

Because of two black dogs on Sweet Street, an entire family of mallard ducks were destroyed in the pond near the Elementary School. State law requires that all dogs must be under the control of the owner at all times. Most people in Town care about their pets and we thank them for that.

AUDITORS REPORT 1993

The accounts of the Treasurer, Selectmen, Town Clerk, Tax Collector, Library Trustees, Trustees of Trust Funds and Tax Title properties have been audited.

There is an over deposit in the Town Clerk's auto registration account to the Treasurer. This year, the Clerk had to contend with inherited errors from the State Motor Vehicle Department.

In the Tax Collector's accounts, several bookkeeping errors were found. The books were returned for correction. Most errors were bookkeeping problems, transposing of figures and the lack of following the transactions through.

This year the new Treasurer had the usual problems--learning the joys of municipal bookkeeping and accounting.

There is a \$4.00 error in the receipts portion of the town accounts--hopefully, this will be found and corrected before this report becomes final.

We are recommending to the Selectmen to have the town checks "pre-printed" differently. This could do away with stale and outstanding checks, which can be a bookkeeping problem to track. Hopefully, the Selectmen's Office will continue to computerize all Town accounts and create a complete tracking system for the same.

All deposits to the Treasurer should be done separately by Department and Account. All funds except the direct deposits from the Town Clerk and Tax Collector should be handled by the Selectmen's Office to the Treasurer for easier tracking.

We would also like to thank Bill Mace for his years of service and expertise as Treasurer. You could be certain his books were always ready for audit.
