Danville's Middle District Little Red Schoolhouse was built in 1834 and remained in use until 1901. Danville's other one-room schoolhouse, the Old Red Schoolhouse in North Danville, was first built in 1780 and was open until 1894-95. At each school a single teacher taught a comprehensive curriculum to all grades with the help of the pupil's themselves. At times as many as eighty children were registered during a given year. They kept warm by fireplace or pot bellied stove, and had only the light from the windows. Today the town and the North Danville Village Improvement Society maintain the buildings as historic landmarks.

This past year the Timberlane School District voted to upgrade their schools. The Danville Elementary School, originally built in 1962 and currently enrolling 329 students, will gain the addition of 12 classrooms, a new gym and library – almost doubling its size! The construction began late in the fall of 1999 and is scheduled for completion in August 2000.

This year it is with both great pride and sorrow that we honor Clyde Goldthwaite in the Town Report.

Pride for a man who was a community leader. Clyde served the town as a police officer for 30 years. Sixteen years of those years, 1967 to 1983, he was the Chief of Police working from his own living room, 24 hours a day. As if that weren't enough, he was also the Road Agent. For 45 years, from 1954 until his retirement in March 1999, Clyde often woke every two hours to make sure Danville's roads were safe for travel. Over the years he also served as a volunteer firefighter and a deputy fire warden and was a member of the Zoning Board of Adjustment and the Hawke Historical Society.

Sorrow for the loss of a good man, friend, father, grandfather and part of the community soul that is Danville. Clyde was always there to lend a helping hand, whether it was sponsoring a youth baseball team, fixing up an abandoned bike, or leaving a basket of food at a doorstep. And he was *always* there with a friendly hello and a kind word for everyone.

Trusted friend of all, we dearly miss his smile, his help and his joyful dedication to our town. Anecdotes abound, but each sound of a snowplow will forever remind us of our lost friend.

Treasured areas of Danville will now be preserved within the newly designated Danville Historic District. In 1996 the town voted to create a Heritage Commission which proceeded to rewrite the Historic Chapter of Danville's Master Plan. In 1998 the Commission drafted two warrant articles to create and regulate a historic district, and worked closely with the Conservation Commission, Planning Board and Board of Selectmen on this project. The warrant articles passed at the 1999 Town Meeting. The Danville Historic District is approximately 400 acres in size, and includes Tuckertown Road, the Town Forest, the 1755 Meeting House, the town's "Parsonage Land." Ye Old Cemetery and the Old Meeting House Cemetery. The area represents the original center of the town while still under British rule, and contributes greatly to the town's historic and overall rural character.

Our town thrives by people contributing their time and ideas. We solicit everyone to volunteer. There is no lack of opportunities to promote change. Thank you for your continuing support.

WARRANT AND BUDGET 2000

To the inhabitants of the Town of Danville in the County of Rockingham in said State, qualified to vote in Town affairs:

First Session of Annual Meeting (Deliberative)

You are hereby notified to meet at the Fire Association Hall in Danville, New Hampshire on Saturday, the twelfth of February at 10.00 a.m. This session shall consist of explanation, discussion, and debate of warrant articles number 11 through 34. Warrant articles may be amended subject to the following limitations: (a) warrant articles whose wording is prescribed by law shall not be amended and (b) warrant articles that are amended shall be placed on the official ballot for a final vote on the main motion as amended.

Second Session of Annual Meeting (Voting)

Voting on warrant articles number 1 through number 34 will be conducted by official ballot at the Fire Association Hall on Tuesday, the fourteenth of March 2000. Polls will be open from 8:00 a.m. and remain open until 8:00 p.m.

- 1) To choose all necessary Town Officers for the year ensuing (March 14th only)
- 2) To choose all School District Officers for the year ensuing (March 14th only)
- 3) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE II., Definitions to read:

Y. RECREATIONAL VEHICLE/CAMPING TRAILER, Paragraph a: "A motor home or van, which is a portable, temporary dwelling to be used for travel, recreation and vacation, constructed as an integral part of a self-propelled vehicle or permanently towable." RECOMMENDED BY THE PLANNING BOARD.

4) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

ADD to ARTICLE III., Zoning Districts and Boundaries:

- HISTORIC DISTRICT, "LOT 1-62. A parcel of land referred to E. as the "Sandilands property", historically known as "The Great Meadow", owned by the Town of Danville since 1999. Historically, the parcel was once owned by the Page family, descendents of Jabez Page, one of the builders of the Meeting House. The parcel abuts Tuckertown Road, part of the existing Historic District, on one of its north bounds. As early as the 1850's the land was used by Daniel Page and his family as a having meadow and was also the site of one or more sawmills. The stone remnants of a mill site are visible on the west side of Main Street just south of Long Pond Road. Daniel Page's son, John, his daughter, Juliette Peaslee and his granddaughter, Henrietta Peaslee all resided in the parsonage house next to the Old Meeting House during their lifetimes. The "Great Meadow" parcel was inherited by Henrietta Peaslee and held by her until her death in 1935. Henrietta Peaslee was the last surviving descendent of the Page family and was instrumental in helping found the Old Meeting House Association in RECOMMENDED BY THE PLANNING BOARD.
- 5) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE IV., <u>Permitted Uses and Restrictions to</u> read:

Section A.. RESIDENTIAL/AGRICULTURAL ZONE, 1., Principal Uses and Restrictions, 1)a. **DELETE** and change to read: "Each dwelling will require a minimum lot or site size of two (2) acres per unit. In no case shall any structure contain more than four (4) units." **RECOMMENDED BY THE PLANNING BOARD.**

6) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE IV., <u>Permitted Uses and Restrictions to read:</u>

Section B., COMMERCIAL/RETAIL AND SERVICE ZONE, 1., Permitted Uses, b. to read: "Book store, stationery or news store, drug store, dry goods store, variety store, florist or gift store, convenience store, grocery store, hardware store, jewelry store, meat market, wearing apparel store, post office, professional office space, restaurant, or similar businesses." RECOMMENDED BY THE PLANNING BOARD.

7) To see if the Town will vote to adopt the amendment to the existing Danville Zoning
Ordinance as follows: (March 14th only)

AMEND ARTICLE V., <u>Supplemental Regulations</u>, Paragraph H., FLOODPLAIN DEVELOPMENT ORDINANCE to read:

Section 1., <u>Definition of terms</u>: **ADD** a new **definition** after "Floodplain" to read: "Flood Insurance Rate Map (FIRM) means an official map incorporated with this ordinance, on which FEMA has delineated both the special flood hazard areas and the risk premium zones applicable to the Town of Danville."

Section 2., <u>General Requirements</u>, c.(3) **DELETE** the last sentence and change to read: "The Building Inspector shall maintain this information for public inspection, and shall furnish such information upon request."

Section 2., General Requirements, e.1) DELETE and change to read: "In riverine situations, prior to the alteration or relocation of a watercourse the applicant for such authorization shall notify the Wetlands Board of the New Hampshire Environmental Services Department and submit copies of such notification to the Conservation Commission, in addition to the copies required by RSA 482-A:3. Further, the applicant shall be required to submit copies of said notification to those adjacent communities as determined by the Conservation Commission, including notice of all scheduled hearings before the Wetlands Board (and notice of local wetlands hearings)."

Section 2., <u>General Requirements</u>, e.2) **DELETE** and change to read: "The applicant shall submit to the Building Inspector and Conservation Commission certification provided by a registered professional engineer, assuring that the flood carrying capacity of an altered or relocated watercourse can and will be maintained."

Section 2., General Requirements, e.3) **DELETE** the first paragraph and change to read: "The Building Inspector and Conservation Commission shall obtain, review, and reasonably utilize any floodway data available from Federal, State, or other sources as criteria for requiring that all development located in Zone A meet the following floodway requirement:"

Section 2., General Requirements, f.2)d) DELETE and change to read: "For all new construction and substantial improvements, fully enclosed areas below the lowest floor that are subject to flooding are permitted provided they meet the following requirements: (1) the enclosed area is unfinished or flood resistant, useable solely for the parking of vehicles, building access or storage; (2) the area is not a basement; and (3) shall be designed to automatically equalize hydrostatic floor forces on exterior walls by allowing for the entry and exit of floodwater. Designs for meeting this requirement must either be certified by a registered professional engineer or architect or must meet or exceed the following minimum criteria: A minimum of two (2) openings having a total net area of not less than one square inch (1 square inch) for every one square foot (1 square foot) of enclosed area subject to flooding shall be provided. The bottom of all openings shall be no higher than one foot (1') above grade. Openings may be equipped with screens, louvers, or other coverings or devices provided that they permit the automatic entry and exit of floodwater."

Section 2., General Requirements, f.2) ADD a new section e) to read: "All recreational vehicles placed on sites within Zones A1-30, AH, and AE shall either (i) be on the site for fewer than 180 (one hundred eighty) consecutive days; (ii) be fully licensed and ready for highway use; or (iii) meet all standards of Section 60.3 (b)(1) of the National Flood Insurance Program Regulations and the elevation and anchoring requirements for "manufactured homes" in Paragraph (c)(6) of Section 60.3." RECOMMENDED BY THE PLANNING BOARD.

8) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE VI., Lot and Yard Requirements to read:

- B. LOCATION OF BUILDING ON LOT, **DELETE** and change to read: "Except as provided elsewhere in this ordinance, no building, mobile home or permanent structure shall be located nearer than fifteen feet (15') to an abutter's property line and thirty feet (30') from the edge of a street, or a distance no nearer the front property line than the average distance of existing properties for five hundred feet (500') in either direction along, and on the same side of said street, whichever is greater." **RECOMMENDED BY THE PLANNING BOARD.**
- 9) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE VII., General Provisions, Section C., SANITARY PROTECTION REQUIREMENTS, 5. DELETE the last two sentences of this section and change to read: "The land application/land filling/stockpiling of sewage sludge, the placement of sewage sludge on the ground surface, or the firing of sewage sludge in a sewage sludge incinerator in the Town of Danville is prohibited. The above-described uses will also be prohibited for ash generated during the firing of sewage sludge in a sewage sludge incinerator, or grit and screenings generated during preliminary treatment of domestic sewage in a treatment works." RECOMMENDED BY THE PLANNING BOARD.

10) To see if the Town will vote to adopt the amendment to the existing Danville Zoning Ordinance as follows: (March 14th only)

AMEND ARTICLE VII., General Provisions, Section D., SIGNS. DELETE and change to read: "The following types of signs shall be permitted: Town, State and Federal Highway directional and regulatory signs, historic signs, those relating to the sale or lease of the premises, the profession or home occupation of the occupant and the sale of goods sold on the premises. No sign or group of signs shall exceed four square feet (4 square feet) in a residential/agricultural zone and twenty-five square feet (25 square feet) in area in all other zones nor shall be so placed so as to obstruct a clear view of the

highway. No lighting of signs shall be allowed in the residential/agricultural zone. Signage shall be constructed and adequately maintained such that it does not pose a health or safety hazard nor shall it be offensive or detrimental to the existing neighborhood as determined by the Selectmen." RECOMMENDED BY THE PLANNING BOARD.

- 11) To see if the Town will vote to raise and appropriate the sum of One Hundred Ninety Thousand dollars (\$190,000) to purchase a Triple 'A' Combination Fire Truck and to authorize the issuance of not more than One Hundred Sixty Thousand dollars (\$160,000) of bonds and notes in accordance with the provisions of the Municipal Finance Act (RSA 33) and to authorize the Board of Selectmen to issue and negotiate such bonds or notes and to determine the rate of interest thereon; furthermore to authorize the withdrawal of Thirty Thousand dollars (\$30,000) from the existing Future Fire Department Vehicle Purchase Capital Reserve Fund created for this purpose. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- To see if the Town will vote to raise and appropriate the sum of Four Hundred Fifty-Nine Thousand dollars (\$459,000) (gross budget) for the construction, computerization, and partial equipping of an addition to the existing Colby Memorial Library as shown in architectural drawings by Lee M. Berard & Consultants and T. F. Moran, Inc. of Bedford, New Hampshire, as amended, and to authorize the withdrawal of One Hundred Seventy-Seven Thousand dollars (\$177,000) and accumulated interest from the Colby Memorial Library Capital Reserve Fund created for this purpose (thereby closing said fund) and to authorize the issuance of not more than Two Hundred Eighty-Two Thousand dollars (\$282,000) of bonds and notes in accordance with the provisions of the Municipal Finance Act (RSA 33) and to authorize the Board of Selectmen to issue and negotiate such bonds and notes and to determine the rate of interest thereon; further, and additionally to accept any federal, state, or private grants and/or donations that may be received. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)

- 13) If Warrant Article #12 passes, to see if the Town will vote to raise and appropriate the sum of \$4,200 (Four Thousand Two Hundred dollars) to be used for the "operating expenses" for the addition to the Colby Memorial Library for the remainder of the year of construction. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 14) If Warrant Article #12 fails, to see if the Town will vote to raise and appropriate the sum of Fifty Thousand dollars (\$50,000) to be added to the existing Colby Memorial Library Capital Reserve Fund. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- **15)** If Warrant Article #11 passes, to see if the Town will vote to allow the Selectmen/Fire Wards to sell Engine #1, a 1966 R85 International, VIN # G195481, for approximately Two Thousand Five Hundred dollars (\$2,500), and Engine #3, a 1963 R202A International, VIN # FD27133G, for approximately Two Thousand Five Hundred dollars (\$2,500), and the funds from the sales to be placed in the existing Capital Reserve Fund for Future Fire Department Vehicle Purchases. This appropriation is in addition to the operating article warrant #34, budget (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 16) If Warrant Article #11 fails, to see if the Town will vote to raise and appropriate Thirty Thousand dollars (\$30,000) to be placed in the existing Future Fire Department Vehicle Purchase Capital Reserve Fund. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 17) To see if the Town will raise and appropriate the sum of Twenty Thousand dollars (\$20,000) to be added to the existing Municipal Building Capital Reserve Account previously established for the future remodeling or repair of the Town Hall. This

appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)

- 18) To see if the Town will vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of building a new police station, as authorized by statute, and to raise and appropriate the sum of Ten Thousand dollars (\$10,000) to be placed in this fund. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 19) To see if the Town will vote to establish a Capital Reserve Fund under the provision of RSA 35:1 for the purpose of site improvement and the repair and replacement of equipment at the Clyde Goldthwaite Recreational Facility, as authorized by statute, and to raise and appropriate the sum of Twenty Thousand dollars (\$20,000) to be placed in this fund. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (NOT RECOMMENDED BY THE BUDGET COMMITTEE)
- 20) To see if the Town will vote to raise and appropriate the sum of Ten Thousand dollars (\$10,000) to be put into the Capital Reserve Fund for a road repair project on Pine Street from Route 111A to the second entrance of Crestwood Drive. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 21) To see if the Town will vote to raise and appropriate the sum of Two Hundred Forty Thousand (\$240,000) to repair the Johnson Road culverts and bridge, and to accept the Bridge Aid Grant of One Hundred Ninety Two Thousand dollars (\$192,000), and to authorize the withdrawal of Sixteen Thousand Two Hundred dollars (\$16,200) from the existing Johnson Road Capital Reserve, leaving a fund balance of Thirty-One Thousand Eight Hundred dollars (\$31,800) to be raised through taxation. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)

- **22)** To see if the Town will vote to raise and appropriate Two Hundred Fifty-Seven Thousand Three Hundred Sixty dollars (\$257,360) for bridge construction on Sandown Road and to accept the Bridge Aid Grant of One Hundred Eighty Eight Thousand dollars (\$188,000) and to authorize the withdrawal of Sixty-Nine Thousand Three Hundred Sixty dollars (\$69,360) from the existing Sandown Road Capital Reserve Fund. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 23) To see if the Town will vote to raise and appropriate the sum of Ten Thousand dollars (\$10,000) to start a Non-Capital Reserve Fund for culvert and/or bridge replacement on Pleasant Street. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- 24) To see if the Town will vote to raise and appropriate the sum of Ten Thousand dollars (\$10,000) to be placed in a Cemetery expendable reserve fund for future cemetery improvements and maintenance, to be administered by the Cemetery Trustees. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (NOT RECOMMENDED BY THE BUDGET COMMITTEE)
- 25) To see if the Town will vote to raise and appropriate the sum of One Hundred Two Thousand Four Hundred Fifteen Dollars (\$102,415) to be used over the next three years for the purpose of hiring, training and employing a full-time Police Officer. This amount will be offset by a grant of Sixty-Seven Thousand dollars (\$67,000) which has been awarded to the Danville Police Department by the Federal Government through the Universal Hiring Grant. This is a non-lapsing warrant article and will lapse in the year 2002. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- **26)** If Warrant Article #25 passes, to see if the Town will vote to raise and appropriate Eleven Thousand One Hundred and Twenty -

Five dollars (\$11,125) for additional equipment, operating expenses and part-time salaries to provide twenty-four hour patrol coverage seven days a week. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)

- 27) To see if the Town will vote to send a resolution to the New Hampshire General Court that natural, cultural and historic resources in Danville and throughout New Hampshire, are worthy of protection and, therefore, the State of New Hampshire should establish funding with available state and/or federal monies for conservation of these important resources. (RECOMMENDED BY THE SELECTMEN)
- 28) To see if the Town will vote to raise and appropriate the sum of Thirty Thousand dollars (\$30,000) to establish a Capital Reserve Fund to fund a Town of Danville Transportation Enhancement Program. The capital reserve fund is for the Town portion of an 80-20 percent grant to create sidewalks, pedestrian safety improvements, and bike paths. If the Town does not receive the grant, the Capital Reserve fund will be used for alternative transportation enhancements to be directed by a future town meeting. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (NOT RECOMMENDED BY THE BUDGET COMMITTEE)
- 29) To see if the Town will vote to raise and appropriate the sum of Twenty Five Thousand dollars (\$25,000) to establish a Capital Reserve Fund for a Property Re-evaluation of the Town of Danville, approximately by the year 2003. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- **30)** To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Four Hundred dollars (\$50,400) to establish bi-weekly curbside recycling. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)

- **31)** In the event that warrant article #30 is passed, to see if the Town will direct the Selectmen to close the existing Recycling and Transfer facilities, and to not relocate the facilities which are currently located behind the Town Hall. (RECOMMENDED BY THE SELECTMEN)
- **32)** To see if the Town will vote to raise and appropriate Fourteen Thousand Four Hundred dollars (\$14,400) to provide bimonthly "curbside bulk clean-up" to remove large waste and debris. This appropriation is in addition to warrant article #34, the operating budget article. (RECOMMENDED BY THE SELECTMEN) (RECOMMENDED BY THE BUDGET COMMITTEE)
- To see if the Town will vote to require a public hearing and a Town ballot vote in the event the Board of Selectmen propose to create a waste "transfer station" or additional recycling site in Town, or expand a current recycling/trash bin site. "Transfer station" is defined as any drop-off area which accepts recyclable materials, household trash, or waste materials of any type including hazardous waste. The current existing transfer station sites for recycling material bins (behind the Town Hall) and household trash bins (behind Town Hall, Fire Association Hall, Danville Village Market, Four Seasons Park, and the Pleasant Street location) may continue to be used, but shall not be expanded without a public hearing and Town ballot vote. No site preparation work shall be performed prior to the ballot vote. The household hazardous waste collection day would continue to occur. (BY PETITION)
- **34)** Shall the Town of Danville raise and appropriate as an operating budget, not including appropriations by other warrant articles, the amounts set forth on the budget posed on the warrant, for the purposes set forth therein, totaling \$1,237,969. Should this be article be defeated, the operating budget shall be \$1,143,998 which is the same as last year, with certain adjustments required by previous action of the Town of Danville or by law, or the governing body may hold one special meeting in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.

INDEPENDENT AUDITORS – 1999 REPORT

To the Members of the Board of Selectmen Town of Danville Danville, New Hampshire

We have audited the accompanying general purpose financial statements of the Town of Danville as of and for the year ended December 31, 1998 as listed in the table of contents. These general purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these general purpose financial statements based on our audit.

Except as discussed in the following paragraphs, we conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

Government Accounting Standards Board Technical Bulletin 98-1, *Disclosures about Year 2000 Issues*, requires disclosure of certain matters regarding the year 2000 issue. The Town of Danville has included such disclosures in Note 5. Because of the unprecedented nature of the Year 2000 issue, its effects and the success of related remediation efforts will not be fully determinable until the year 2000 and thereafter. Accordingly, insufficient audit evidence exists to support the Town of Danville's disclosures with respect to the year 2000 issue made in Note 5. Further we do not provide assurance that the Town of Danville is or will be year 2000 ready, that the Town of Danville's year 2000 remediation efforts will be successful in whole or in part, or that parties with which the Town of Danville does business will be year 2000 ready.

The general purpose financial statements referred to above do not include the general fixed assets account group which should be included in order to conform with generally accepted accounting principles. As is the case with most municipal entities in the State of New Hampshire, the Town of Danville has not maintained historical cost records of its fixed assets. The amount that should be recorded in the general fixed assets account group is not known.

In our opinion, except for the effect on the financial statements of the omission described in the preceding paragraph, along with the effects of such adjustments, if any, as might have been determined to be necessary had we been able to examine evidence regarding year 2000 disclosures, as noted above, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Danville, as of December 31, 1998, and the results of is operations and the cash flows of its nonexpendable trust funds for the year then ended in conformity with generally accepted accounting principles.

Our audit was made for the purpose of forming an opinion on the general purpose financial statements of the Town of Danville taken as a whole. The combining and individual fund financial statements listed as schedules in the table of contents are presented for purposes of additional analysis and are not a required part of the general purpose financial statements of the Town of Danville. Such information has been subjected to the auditing procedures applied in the audit of the general purpose financial statements and, in our opinion, is fairly presented in all material respects in relation to the general purpose financial statements taken as a whole.

FIRE DEPARTMENT - 1999 REPORT

We continued to place emphasis on continuing education in both emergency medical services and fire suppression. We hosted over 25 training events this year including a "live burn" in which a fire was deliberately set in an abandoned residence and the building burned. We have also implemented a new computerized accounting and tracking system that enables us to more accurately and efficiently track the numerous requirements of the fire service.

The new rescue vehicle authorized by the vote of the Town is scheduled for delivery in February of 2000. This vehicle will have full transport capability as well as specialized equipment to allow us to continue to provide advanced life support care to those in need. We have also purchased a new 12-lead electrocardiogram (EKG) that will enable us to more accurately read and interpret cardiac rhythms and provide proper medical support. This will also lead to more timely administration of clot breaking medications within the hospital emergency department (and soon within the pre-hospital environment). Fifty percent of the purchase cost (\$6,000) was made possible by a donation from the Danville Fire Association.

This year we will be looking for support of the Town's people in our request for funds to purchase a new fire apparatus. This new truck will replace two old and obsolete trucks — one of which is no longer in service due to lack of availability of parts to replace the braking system.

POLICE DEPARTMENT - 1999 REPORT

This past year was a very rewarding and memorable year for the Police Department. First, we applied for several State and Federal Grants. We were fortunate to receive awards in excess of \$78,000.00. They included:

- 1. \$1,147.00 for DWI Overtime Patrols
- 2. \$1,147.00 for Selective Enforcement patrols.
- 3. \$9,000.00 Block Grant for computer hardware and software.
- 4. \$67,500.00 COPS Universal Grant to help fund an additional Full Time Officer over (3) years.

The COPS Universal Grant will be discussed and voted on at this years Town Meeting. This is an opportunity for the Police Department to provide 24 hour patrol coverage at a reduced cost to the town.

A fifth grant to help subsidize the cost of ballistic vests purchased in 1999 is also in process and we are waiting notice of award. All these grants help offset the burden of taxpayers to fund these programs.

I am please to announce our website went on line last year and can be reached on the Internet at www.mindspring.com/~danvillenhpd. It offers a host of information about our department including weekly police logs as well as hyper links to other related sites. Please visit us often and if you have any

suggestions on improving the site or wish to receive additional information on a related topic, feel free to call the department or send an E-mail.

Despite our patrol efforts, we continued to receive a large number of speed related complaints last year. We grew increasingly concerned given the growing number of activities taking place around the ball field, school and Town Offices. As a result, we created a task force to examine the speed limits throughout town. Together with Officials from the Department of Transportation, we were able to reduce the speed limit on Main Street to 30 MPH near the center of town. Unless posted otherwise, all other roads in town are 30 MPH.

In December, with the assistance of Federal, State, County and local authorities, we intercepted a package containing 29 lbs. of Marijuana inbound from California -- blemishing a common notion that these types crimes are limited to larger communities. While the case was still under investigation at the time of this print, it was the Departments largest drug bust to date interrupting a distribution hub in Southern New Hampshire and Massachusetts. To date, two arrests have been made and several more are expected.

One of the more memorable moments last year was the lighting of Danville's first Town Christmas Tree. We were fortunate to sponsor the event with the help of so many people. The children at the elementary school crafted handmade ornaments and decorated the tree while hundreds of residents joined in the fun by singing carols and sharing in the spirit of the season. Pizza and refreshments were served after to all those who attended. This year a permanent tree will be planted near the same location to be enjoyed for years to come. The decorating and lighting will be an annual event.

While losing friends is never easy, last year was especially difficult with the passing of Clyde Goldthwaite. Although officially Clyde served more than 30 years on the department before retiring, he continued to assist the department in all the years that followed. He will be sorely missed.

Once again, thanks to everyone that helped make last year such a success. Special appreciation to Des-Con Systems LTD for donating the handcrafted conference table, Frank Perreault for all his PC wizardry (you are a genius!) and Danville's anonymous "Santa" for all the generous donations . Incredible!

My very best to all of you for a safe and happy new year.

The 1999 season started with a very icy January. Although we did not have much snow during the year, the ice and freezing rain is still the most difficult to treat.

The summer season started with cleaning out of ditches and culverts on some roads. They all need it but it is a slow process and can only be accomplished one at a time.

We also began trimming of brush on the roadsides. This is taking time, but with the lack of snow so far during the 1999-2000 season, hopes to continue this project are underway until the weather does not cooperate.

We started the reclamation project on Sandown Road, with the grinding of the old pavement, grading the road surface and resurfacing, we will continue with this project in 2000.

The paving went well but we still have several more roads to resurface. Hopefully this year we will be able to start with the Johnson Road and Sandown Road bridge projects. We have been accepted for the bridge aid that was applied for to help fund these projects.

In March, Clyde decided to leave his post as Road Agent after 45 years of service. He felt it was time to pass the torch on – He did so leaving the reins to me but was always there for support and questions. In September, after helping with a storm, someone else decided it was time for him to help them. He left a town full of love and caring for a special place. We will all miss him, we always appreciated everything he did and everything he was. He was a special man who was dedicated to his town and his service to this town. He will always be there in our hearts. May we all remember him for everything he was.

COLBY MEMORIAL LIBRARY - 1999 REPORT

We had another very busy year. We have registered 128 new patrons. There were 8,407 patron visits and a circulation of 15, 024. We added 1,270 books and 20 videos to the collection.

We have family passes for the Museum of Science in Boston. Please call or come to the library to schedule a day at the museum.

In January we received 91 new children's picture books from the Brownstone Foundation in New York City. In June we were the recipients of a grant from the Children's Literacy Foundation (CLIF) in Hanover, N. H. Duncan McDougall, the founder of CLIF, brought 80 new children's books to a reception for the public held at the library, where he read stories and spoke on the importance of reading to the many families who attended.

Once Upon a Summer Reading was the slogan for our summer reading program. 101 children participated in this program reading 1,155 books. Odds Bodkin was the storyteller for the kick-off program. Odds is a master storyteller, musician, and author. In August we had our annual picnic and children who had participated received certificates and prizes.

For years our library has been overcrowded. We have over 3000 books in storage at the Town Hall. Plans for a 4000 square foot addition are going before the voters in March. It will be a handicapped accessible, two-level addition with increased parking. There will be a separate children's room and there will be computers available to access the library catalog as well as to access the internet. Please stop in to see the artist's rendering of the addition.

Thanks to all the people who donated books, videos, magazines, and audios. Thanks to the Friends of the Library for their continued support. They held a yard sale this year, helped to pay for the summer program, paid to fix the copy machine, and paid for \$350.00 worth of books in December. Thanks also to Boy Scout Troop 13 for their help moving books to the yard sale and cleaning-up after.

Library hours are Monday and Tuesday 1-8 P.M., Wednesday 9:30 A.M.-12 P.M., Thursday 11 A.M.-8 P.M., and Saturday 9:30 A.M.-1 P.M. Pre-school story times are held on Thursday at 10 AM.

PLANNING BOARD - 1999 REPORT

The Danville Planning Board had another very productive year. 1999 began with updates to the Town's Site Plan Review Regulations and passage at the Town meeting of several zoning changes including:

- Creating an Historical District;
- Eliminating the need for some home occupations to come before the Board of Adjustment; and
- Further protecting the Town's wetlands

While the number of subdivision applications that came before the Board continued its downward trend, it continued to be a busy year for the Planning Board. The Board continued its work to ensure that the subdivisions that were approved were in the tradition and character of the existing Danville community. The Board also spent a large amount of time updating our Subdivision Regulations and Zoning Ordinance once again to preserve our Town's unique character. This has culminated in several proposed zoning changes that will appear on the 2000 Town Warrant. We ask for your support on these zoning changes.

In 2000, the Planning Board hopes to update the Town's Excavation Regulations. We intend to pursue a grant from the Rockingham Planning Commission to help in this endeavor.

Finally, the Board wishes to thank the residents of Danville for the interest they have shown in Town Planning and we ask for your continued support in the future.

CONSERVATION COMMISSION - 1999 REPORT

In 1999, the Conservation Commission finalized their town-wide natural resource inventory. The inventory documents the existence of several environmental parameters into a written report. It also includes a large aerial photo of the town as well as several large maps showing the Town's groundwater resources, contours, wetlands, soil types, flood plains and lands of special importance. The aerial photo and maps have been laminated and are displayed at the town hall for use by town boards, committees and the general public. The inventory will help the town to decide which lands should be protected due to their environmental/recreational significance. Danville's natural resource inventory has been included in Rockingham Planning Commission's Regional Environmental

Planning Program (REPP), for which a draft report has also been produced. This report consolidates the natural, cultural and historic resources data for towns in Rockingham County. The REPP will assist Danville in working with other towns to develop regional protection strategies for contiguous parcels of land that cross town boundaries and are of environmental/recreational significance. The Commission also purchased several maps that were produced by the Exeter River Watershed Project. These maps, also laminated and displayed in the town hall, illustrate the environmental significance as well as the extent of the watershed's influence in northern Danville.

The Conservation Commission also worked with the New Hampshire Department Fish and Game to install a water level control device at a beaver dam on land that was recently purchased by the Town with current use change tax funds. The device was installed to control flooding on Tuckertown Road. The Commission will also be working with Fish & Game this next year to coordinate the installation of Wood Duck boxes at this location.

Other accomplishments this last year included review of one dredge and fill permit application, which the Commission did not recommend for approval by the State. We also reported a violation of the Shoreland Protection Act to the State Department of Environmental Services. The violation occurred on Long Pond and the property has since complied with all state requirements. The Commission also participated in the NH PURE Campaign's Life Wise Community Projects. This involved coordinating environmental education demonstrations for the forth and fifth grades at Danville Elementary School. The interactive demonstrations illustrated the importance of groundwater protection in the community.

The Conservation Commission meets the first Wednesday of each month at 7:30 PM at the Town Hall. Meetings are open to the public and we encourage the public's attendance and participation. Persons interested in becoming a member should submit a letter of interest to the Selectmen.

HERITAGE COMMISSION - 1999 REPORT

The last year of this century will be remembered as one of tribute and honor for the Town's history and heritage and perpetuation of the townspeople's desire to preserve and protect the Town's character and historic resources.

On March 9, 1999 the voters of Danville approved the two warrant articles necessary to establish Danville's historic district. Although a zoning protest petition was filed, requiring a 2/3 vote, the people's vote of 798 to 287 and 784 to 306 on the two articles ensured passage and creation of the historic district. The Heritage Commission wishes to acknowledge the efforts of Danville's multiple town boards--the Board of Selectmen, Planning Board and Conservation Commission--in working with the Heritage Commission to develop and support the historic district ordinances. As a result of the work of these boards and the overwhelming support of the townspeople, more than 400 acres of treasured town-owned properties in and around the area of the Old Meeting House, Tuckertown Road and the Town Forest will now be protected and preserved for all to enjoy and this area will continue to contribute to the Town's historic and overall rural character.

On May 22, 1999 the Town of Danville was honored by the New Hampshire Office of State Planning when it received an Award of Merit for the Town's new historic district. The award was presented to the Heritage Commission at the annual Planning and Zoning Conference in Concord. Danville received one of four awards that are presented annually for planning and zoning projects of special merit that exemplify good local planning and sound judgment. The award is displayed at the Town Hall.

Also in May all members of the Commission and its clerk installed the new marker in a cement base at the Beehive Hut .

Early this year Heritage Commission member Phil Cote sought out Ruth Rich, author of Danville's only written history book, The History of Danville, New Hampshire, first published in limited number in 1975 in honor of the Town's 215th birthday. With Phil's encouragement, Mrs. Rich, who now resides in Oregon, graciously agreed to re-publish and sell at cost 200 additional copies of the book. Nearly all of the new books were sold in a short period of time.

On August 22, 1999 (Old Home Day) members of the Hawke Historical Society, Old Meeting House Association, Village Improvement Society and Conservation Commission joined with the Heritage Commission in the opening of ten of Danville's historical buildings and sites to the public. With guides at each site, at least 150 people visited the Town Pound, the Beehive Hut, Danville's two red schoolhouses, the Old Meeting House, Ye Olde Cemetery, Tuckertown Road, the North Danville Union Church, the Sargent Cooperage and the White Schoolhouse/Sanborn Library.

Throughout the year the Commission has continued its bulletin board project in the Town Hall, local educational newspaper articles about the Town's history, and cataloging and organizing the old documents and records at the Town Hall. Members have worked with the Selectmen on issues regarding the use of Tuckertown Road for a graveling project, development of a trails and pedestrian transportation enhancement plan and possible renovation of the second floor of the Town Hall. The Commission has also taken initial steps to apply for listing of the Town Hall building in the National Register of Historic Places. The New Hampshire Division of Historic Resources has deemed the Town Hall eligible to proceed with the official Federal application.

The Town Heritage Fund, established by the voters in 1997, is still in place for bequests or donations to help further the identification, preservation and protection of Danville's heritage and historic resources.

The Heritage Commission meets on the second and fourth Wednesday of each month at 7:30 P.M. and most meetings are televised. There are several openings on the Commission. Anyone wishing to join may contact the Board of Selectmen.
