29	spoken with Jason for some available dates where he can be present for the continuance of the hearing
30	The Board has a brief discussion of the available dates and all agreed on Wednesday, January 18, 2023

33	Chairman Stafford then opens the public hearing. David Knight recuses himself. Roger made and John
34	2 nd a motion to continue this hearing until January 18 , 2023. All in favor, motion carries with a vote of
35	4-0.

37	Roger requests that the Board re-visit the Rules of Procedure to amend having an alternate member
38	take the place of a voting member during deliberation if the alternate has been to all previous meetings
39	Walter noted that he is willing to write up an amendment for discussion on January 18,

41	Roger made and John 2 nd a motion to adjourn. All in favor, motion carries with a vote of 4-0. Meeting
42	adjourned at 7:45pm
